The Regulations, which come into operation on the 1st November, 1954, have been published as Statutory Instrument, 1954, No. 1399. The Regulations raise the limit upon the maximum holding of National Savings Certificates (Ninth Issue) by any one person from 700 units to 1,000 units.

The Lords Commissioners of Her Majesty's Treasury also give notice that as from the 1st November, 1954, the limit on individual holdings of 3½% Defence Bonds (Subscription Issue), other than those acquired by inheritance, will be raised from £1,000 to £2,000.
