The Minister of Transport and Civil Aviation on the 20th October, 1954, made the Berwick Harbour Commissioners (Borrowing Powers) (Revocation) Order, 1954 (S.I. 1954 No. 1391) which will come into operation on the 30th October, 1954.

This Order revokes the Berwick Harbour Commissioners (Borrowing Powers) Order, 1941, which was made under Regulation 56 of the Defence (General) Regulations, 1939, and which empowered the Commissioners to borrow a sum not exceeding two thousand pounds for the purpose of carrying out repairs to the structure of Berwick Pier.
