Notice of Determination to Modify Particulars Contained in The Draft Rights of Way Map for East Berks.

NOTICE is hereby given that the Berkshire County Council in exercise of the powers conferred upon them by sub-section (3) of section 29 of the National Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the draft rights of way map and statements prepared under section 27 of the said Act in relation to the rights of way within the eastern area of the County of Berks. (comprising the Boroughs of Maidenhead, New Windsor and Wokingham and the Rural Districts of Cookham, Easthampstead, Windsor and Wokingham) by the deletion of the paths described in the First Schedule hereto and by the addition of public rights of way described in the Second Schedule hereto.

NOTICE is hereby further given that maps showing the effect of these modifications have been deposited and may be seen free of charge during normal office hours at the following offices:—

In addition the Draft Map as originally deposited may be seen at the Shire Hall and relevant sections thereof together with particulars of all modifications may be seen at the offices of the aforementioned Borough and Rural District Councils and at an address in each Parish to be ascertained from the Parish Chairman or Clerk. Any representation or objection with respect to these determinations shall be made in writing addressed to the undersigned before the Fourth day of December, 1954 and shall state the grounds on which it is made.
