- "1. Union of Benefices. The benefice of Mereworth and the benefice of West Peckham shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Mereworth with West Peckham', but the parishes of the said benefices shall continue in all respects distinct.
- "2. Taking effect of union. If upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette both of the said benefices shall be vacant the union shall forthwith take effect, but if they shall not be so vacant the union shall take effect upon the first avoidance of that one of the said benefices last to be avoided after that day.
- "3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Mereworth shall be the house of residence of the incumbent of the united benefice.
- "4. Patronage. After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Mereworth having the first presentation to the united benefice to be made after the union."
