

In the High Court of Justice (Chancery Division) before Mr. Justice Wynn-Parry

In the matter of THE BRITISH ALBUMEN COMPANY Limited and in the matter of the Companies Act, 1948.

And it was ordered that the Petitioners the said The British Albumen Company Limited and Robert Clifford Glaze do pay to the Registrar of Companies his costs of the said Petition such costs to be taxed
