"(2) Parish Church. The church of Saint Mary and All Saints, Haselor, shall be the parish church of the parish of Haselor.

- "(3) Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect.
- "(4) Parsonage house. The parsonage house at present belonging to the benefice of Kinwarton with Great Alne shall be the house of residence of the incumbent of the united benefice.
- "(5) Patronage. After the union has taken effect in every series of three successive turns of presentation or nomination to be made to the united benefice the patrons of the benefice of Kinwarton with Great Alne shall have the first and third turns and the alternate patron of the benefice of Haselor with Billesley who was formerly sole patron of the benefice of Haselor (or his successor in title) shall have the second turn.

- "2. Union of the benefices of Saint Andrew, Wilmcote. and Billesley.

 "(1) Union of benefices. The benefice of Saint Andrew, Wilmcote, and the remaining part, namely Billesley, of the benefice of Haselor with Billesley shall be permanently united together and form one benefice with cure of souls under the style of 'The United Benefice of Wilmcote with Billesley' and the varishes or places forming or comprised in the said parishes or places forming or comprised in the said benefice and part of a benefice shall be united into one parish for ecclesiastical purposes and the parish church of the parish of Saint Andrew, Wilmcote, shall be the parish church thereof.
- "(2) Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union Schelle is published in the London Gazette the union shall forthwith take effect and the Reverend Aubrey Gilbert Roy Churchill, if he is then incumbent of the said benefice of Saint Andrew, Wilmcote, shall, with his consent (testified by his signature hereto) be the first incumbent of the united benefice.
- "(3) Parsonage House. The parsonage house at present belonging to the benefice of Saint Andrew, Wilmcote, shall be the house of residence of the incumbent of the united benefice.
- "(4) Patronage. After the union has taken effect in every series of four successive turns of presentation or nomination to be made to the united benefice the patron of the said benefice of Saint Andrew, Wilmcote, shall have the first, second and third turns and the alternate patron of the benefice of Haselor with Billesley who was formerly sole patron of the benefice or Billesley (or his successor in title) shall have the fourth have the fourth.

Upon the taking effect of the unions hereinbefore recommended and proposed a portion of the endowments of the benefice of Haselor with Billesley namely:-

"(a) a money payment in lieu of tithe charged on lands in the parish of Haselor by virtue of an Award dated the 17th day of June, 1767, made pursuant to an Act of the sixth year of the reign of King George the Third, chapter 2, and amounting to £6 13s. 4d. per annum,

"(b) a capital sum, being part of a larger capital sum at present held by us on behalf of the benefice of Haselor with Billesley, sufficient to produce £182 per annum.

per annum,

shall be annexed to that part of that benefice which under the provisions of this Scheme is to be united with the benefice of Kinwarton with Great Alne and

with the benefice of Kinwarton with Great Alne and all other the endowments and property of the said benefice of Haselor with Billesley shall be annexed to the remaining part of that benefice which is to be united with the benefice of Saint Andrew, Wilmcote."

And whereas the provisions of the Union of Benefices Measures, 1923 to 1952, the Union of Benefices Rules, 1926 and 1930, and the Pastoral Reorganisation Measure, 1949, relating to the preparation and submission of this Scheme have been duly complied with: complied with:
