

close number 205 and continuing thence northwards to and along the last mentioned wall or fence and along the walls or fences forming the western boundaries of closes numbered 171 and 162 to the wall or fence which forms the south-eastern boundary of close number 153 and continuing thence in a straight line, thereby crossing Rainworth Water and closes numbered 153 and 151, to the southeastern end of the wall or fence forming the southwestern boundary of close number 145 and continuing thence first north-westwards and then north-eastwards along the last mentioned wall or fence and along the wall or fence forming the north-western boundary of the last mentioned close to its junction with the wall or fence forming the southwestern boundary of close number 90 and continuing thence north-westwards along the last mentioned wall or fence and along the walls or fences forming the southwestern boundaries of closes numbered 117, 114, and 92 to the eastern end of the wall or fence forming the northern boundary of close number 112 and continuing thence westwards along the last mentioned wall or fence to its junction with the wall or fence forming the eastern boundary of close number 103 and continuing thence southwards along the last mentioned wall or fence and along the walls or fences forming the eastern boundaries of closes number 104 and 120 and in a straight line in continuation thereof to a point in the middle of the road or track numbered close 127 and continuing thence generally westwards along the middle of the last mentioned road or track and along the middle of the road or track leading in a westerly direction across close number 124 to the boundary which divides the extra-parochial place known as Rufford Abbey from the parish of Saint Alban, Forest Town, and continuing thence southwestwards along the middle of the road or track leading to Oak Tree Lane to the boundary which divides the parish of Saint Alban, Forest Town, from the parish of Saint Lawrence, Mansfield."
