UNIVERSITIES OF OXFORD AND CAMBRIDGE ACT, 1923.

A Statute made by the University of Oxford on the 8th March, 1955, has been submitted for the approval of Her Majesty in Council, and notice of its having been so submitted is published in accordance with the provisions of the Universities of Oxford and Cambridge Act, 1923.

THE PUBLIC SCHOOLS ACT, 1868.

THE GOVERNINO BODY OF RUGBY SCHOOL having on the 24th day of February, 1955, in virtue of the powers conferred upon them by the above-named Act, made a Statute in the terms appended hereto amending the existing Statutes of the said School, the said Statute is hereby published in the London Gazette in accordance with the provisions in that behalf contained in the said Act.

And Notice is hereby given, that any person, body of persons, or body corporate, authorized in that behalf by the said Act, may, within two months after the publication of this notification, petition Her Majesty in Council to withhold Her approval from the whole or any part of the said Statute.

STATUTE MADE BY THE GOVERNING BODY OF RUGBY SCHOOL ON THE 24TH DAY OF FEBRUARY, 1955.

RESOLVED that the Statutes of the School be amended by the enactment of the following Statute V (A):—

"The Second Master.

V (A).

1. The Governing Body after consultation with the Head Master may nominate a Master at the School to be Second Master; and such nomination may be made of a person about to be appointed a Master to take effect from his appointment. The person nominated shall continue to be the Second Master until the Governing Body shall at their pleasure otherwise decide or until he ceases to be a Master.

2. The Second Master shall be responsible to the Head Master. He shall act as the deputy of the Head Master, and shall perform such duties as the Head Master in his discretion shall delegate to him from time to time. During the illness of the Head Master, or his absence from Rugby, and during a vacancy in the Head Mastership, until a new Head Master shall be appointed, the Second Master shall assume the duties and perform the functions of Head Master.

3. His salary and emoluments shall be subject to the directions from time to time of the Governing Body."
