**HAIR, BASS AND FIBRE WAGES COUNCIL (GREAT BRITAIN).**

The Hair, Bass and Fibre Wages Council (Great Britain) hereby gives notice of its intention to submit to the Minister of Labour and National Service proposals for (1) fixing statutory minimum remuneration in substitution for the statutory minimum remuneration set out in the Hair, Bass and Fibre Wages Council (Great Britain) Wages Regulation Order, 1954 (Order H.B.(43)); (2) the revocation of Order H.B.(43); and (3) the amendment of the Hair, Bass and Fibre Wages Council (Great Britain) Wages Regulation (Holidays) Order, 1951 (Order H.B.(37)). The Wages Council will consider any written representation with respect to the above-mentioned proposals which may be sent to it within fourteen days from 25th March, 1955. The Civil Service Commissioners hereby give notice that the following Regulations are published with the approval of the Lords Commissioners of H.M. Treasury, viz.:—

**REGULATIONS FOR THE RECRUITMENT OF MEN AND WOMEN WHO HAVE SERVED OR ARE SERVING IN H.M. FORCES TO THE EXECUTIVE CLASSES (GENERAL AND DEPARTMENTAL) OF THE HOME CIVIL SERVICE.**

1. No candidate may compete more than twice under these or similar Regulations.

2. *Age.*

There is no upper age limit, but in appointing persons in a permanent capacity Departments expect regular and effective service for a reasonable period, and the Commissioners will take this requirement into account.

3. *Sex and Marriage.*

(i) Men only are eligible for Section I. Both men and women are eligible for Sections II and III, but women will not ordinarily be appointed to posts in the Admiralty or War Office or to the Immigration Service of the Home Office.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid. Provided that this undertaking will not be required if the break between the
