The Hydrocarbon Oil Duties (Drawback) (No. 1) Order, 1955, which provides for the allowance of drawback of customs or excise duty paid in respect of hydrocarbon oil used in the manufacture or preparation of pressure pipes, and screw joints for use with them, made of asbestos cement and coated with bitumen paint.

The drawback applies when the articles are exported, or shipped or deposited in warehouse for use as stores, on or after 6th April, 1955.

The Schedule to the Order specifies the rate for determining the quantity of hydrocarbon oil in respect of which drawback is to be allowed.

The Order comes into operation on the 6th April, 1955, and has been published as Statutory Instruments 1955, No. 506.
