REGULATIONS FOR RECRUITMENT TO THE NATIONAL AGRICULTURAL ADVISORY SERVICE UNDER THE MINISTRY OF AGRICULTURE AND FISHERIES.

MINISTRY OF AGRICULTURE AND FISHERIES.

1. Age.

Candidates must on 1st August, 1955, be at least 18 years of age for appointment to Grade B, at least 20½ years of age for appointment to Grade IV (a) or Grade IV (b), at least 25 years of age for appointment to Grade III, at least 26 years of age for appointment to Grade A, and at least 31 years of age for appointment to Grade I or Grade II. Provided that a candidate under 25 years of age on 1st August, 1955, may be accepted for appointment to Grade III if he is exceptionally well qualified.

There is no upper age limit specified for this Competition, but in appointing persons in a permanent capacity Departments expect regular and effective

service for a reasonable period, and the Commissioners will take this requirement into account.

2. Sex and Marriage.

(i) Both men and women, including ma women, may compete under these Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible for appointment under these Regulations to situations which render them eligible for pension and other benefits under the Superannuation Acts, unless they undertake to refund on appointment the marriage gratuity paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of reestablishment is more than seven years. (a) Candidates for Grades I to IV must normally possess a University degree in agriculture, dairying, horticulture, or the appropriate natural sciences, or engineering, or a National Diploma in appropriate subjects, or a qualification accepted by the Commissioners as of equivalent academic standard. For Grade IV (a) candidates must have obtained a University degree with first or second class honours in the appropriate scientific subject or an equivalent qualification. In addition candidates for general agriculture (Section III 1), horticulture (Section III 2) or husbandry (Section III 3) posts should normally have had appropriate practical experience, and for posts at Experimental Husbandry Farms experience in experimental technique is an advantage.

Applications will be entertained, exceptionally, from persons without formal qualifications, provided that they possess sufficient experience of practical farming or horticulture and, preferably, experience of advisory work. Where subjects are not covered by degree courses preference will be given to candidates with the best available academic or professional expelifications.

(b) Candidates for Grades A and B must normally possess either (1) a University degree in science or (2) the Higher School Certificate with mathematics or a science subject as a principal subject or (3) a General Certificate of Education with passes in five subjects at the levels shown in brackets:—

(ii) Two mathematical or scientific subjects (Advanced).

(Passes at the Scottish Universities Preliminary Examination will be accepted as equivalent to passes in the Scottish Leaving Certificate), or (5) a qualification accepted by the Commissioners as equivalent to (1), (2), (3) or (4) for the purpose of this Commetition Competition.

Applications will be entertained exceptionally Applications will be entertained exceptionally from persons without these qualifications, provided that for laboratory posts they have had a fairly comprehensive laboratory or analytical experience; and that for field posts they have had sufficient experience of practical farming or have taken a course of instruction in agriculture or a cognate subject, or have had experience in experimental techniques.

Candidates with specialised knowledge or experience will be considered for posts for which they appear to be best fitted.

(c) Candidates sitting for their examinations in the summer of 1955 may be admitted to this competition; a candidate will not, however, be appointed unless on the result of the examination he or she satisfies Regulation 4 (a) or 4 (b) above.

(d) Ability to drive a motor car is necessary for almost every post in the Service, and candidates who do not hold a current driving licence are normally expected to obtain one within three months of taking appointment.

Successful candidates must satisfy the Commissioners as to their health and character.

Candidates who appear from their applications to have the best qualifications will be summoned to a Selection Board in London consisting of representatives of the Civil Service Commissioners and the Ministry of Agriculture and Fisheries. The Selection Board will take into consideration the candidates' record of education, training and experience, with due regard to loss of opportunity and professional knowledge by those who have served in the Forces, any recommendation that they may receive from persons named by candidates as having direct knowledge of their work in the past, and the personal qualities of the candidates as shown at the Interview.

The Selection Board will recommend the grade and The Selection Board will recommend the grade and type of work in which a successful candidate will be offered appointment, and may recommend a candidate to a grade or type of work other than that for which he has applied. If a candidate is to be interviewed solely for a grade or type of work other than that for which he has applied, he will if possible be informed before being summoned for interview. The decision of the Commissioners will be final.

Candidates Trained as Teachers.

Persons upon whose training for the occupation of teacher public money has been spent cannot be appointed until the consent of the appropriate central education authority (e.g., the Ministry of Education, the Scottish Education Department, the Ministry of Education for Northern Ireland) has been notified to the Commissioners.

8. Canvassing.

Any attempt on the part of candidates to enlist support for their application through Members of Parliament or other influential persons, except as referees to be named by them on their application forms, will disqualify them for appointment.
