in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish: "And whereas we are satisfied that a suitable

endowment therefor will be provided: "And whereas we have not approved any conse-

crated church within the area as suitable to be the parish church of the new parish :

"Now, therefore, with the consent of the Right Reverend Falkner, Bishop of Chelmsford (in testi-mony whereof he has set his hand and affixed his episcopal seal to this Scheme), we do humbly recom-mend and propose as follows, that is to say:—

"1. Constitution

"(a) As from the date of the licence thereto of a Minister, the area defined in the subjoined Schedule and delineated on the map hereto annexed

shall be a separate district for spiritual purposes. "(b) As from the date of the consecration of a church within the area, approved by us as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish. "(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint James, Collier Row.'

"2. Archdeaconry and Rural Deanery:

"The parish shall be in the Archdeaconry of West Ham and in the rural deanery of Chafford.

" THE SCHEDULE.

"The area comprising:— "All those contiguous parts of the parishes of Romford; The Ascension, Collier Row, Romford; and Havering-atte-Bower (coloured pink on the map annexed hereto) which are bounded partly on the southeast by the parish of Romford, on the southwest by the parish of The Good Shepherd, Collier Row, Romford and on the remaining idea Collier Row, Romford, and on the remaining sides by an imaginary line commencing at a point on the boundary which divides the parish of The Ascension, Collier Row, Romford, from the parish of The Good Shepherd, Collier Row, Romford, in the middle of Collier Row Lane opposite the middle of the western end of a track or footpath leading from the last mentioned lane to Havering Road and continuing thence generally northwards along the last mentioned lane and along the middle of Clockhouse Lane to a point opposite the middle of the western end of Saint John's Road and of the western end of Saint John's Road and continuing thence eastwards to and along the last mentioned road to its end and in a straight line in continuation thereof to a point in the middle of the road known as Orange Tree Hill and con-tinuing thence southwestwards along the last mentioned road to its end and in a straight line in continuation thereof to the boundary which divides the parish of The Ascencion Colling Bary continuation intereor to the boundary which divides the parish of The Ascension, Collier Row, from the parish of Havering-atte-Bower and continuing thence generally along the last mentioned boundary to the point where it joins the boundary which divides the parish of Romford from the parish of Havering-atte-Bower and continuing thence east-words elegentic boundary between the parish wards along the last mentioned boundary for a distance of nineteen chains approximately to a point in the middle of an unnamed brook or stream and continuing thence generally southwards and then southwestwards along the middle of the last mentioned stream to a point in the middle of Pettit's Lane and continuing thence generally northwestwards along the last mentioned lane to the boundary which divides the parish of Romford from the parish of The Ascension, Collier Row, Romford."

And whereas the provisions of the New Parishes Measure, 1943, relating to the preparation and sub-mission of this Scheme, have been duly complied with :

Now, therefore, Her Majesty, by and with the advice of Her said Council, is pleased hereby to ratify the said Scheme, and to order and direct that the same and every part thereof shall be effectual in law immediately upon the publication of this Order in the London Gazette pursuant to the said Measure.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 23rd day of March, 1955, in the words and figures following, that is to say:— "We, the Church Commissioners, acting in pursu-ance of the Archdeaconries and Rural Deaneries Act, 1874, and of the Acts mentioned therein, have pre-pared and now humbly lay before Your Majesty in Council the following scheme which we have pre-pared with the consent of the Right Reverend William, Bishop of Bath and Wells (in witness whereof he has signed and sealed the same), with respect to some of the rural deaneries within the archdeaconries of Wells and Taunton both in the diocese of Bath and Wells.

" SCHEME.

"As from the day on which any Order of Your Majesty in Council ratifying this Scheme shall be published in the London Gazette and without any assurance in the law other than such duly gazetted Order:

"(1) The rural deanery of Milborne Port within the archdeaconry of Wells shall cease to exist. "(2) There shall be transferred to the rural

deanery of Merston within the archdeaconry of Wells the parishes of Charlton Horethorne, Corton Denham, Sandford Orcas, Goathill, Henstridge, Milborne Port and Temple (or Abbas) Combe now in the rural deanery of Milborne Port within the same arch-deaconry and the parish of Pendomer now in the rural deanery of Martock within the same archdeaconry.

"(3) There shall be transferred to the rural deanery of Bruton within the archdeaconry of Wells the parsing of Horsington now in the rural deanery of Milborne Port within the same archdeaconry.

"(4) There shall be transferred to the rural deanery of Cary within the archdeaconry of Wells the parish of North Cheriton now in the rural deanery of Milborne Port within the same archdeaconry. "(5) There shall be transferred to the rural deanery

(5) There shall be transferred to the rural deanery of Quantoxhead within the archdeaconry of Taunton the parish of Aisholt now in the rural deanery of Bridgwater within the same archdeaconry.
(6) There shall be transferred to the rural deanery of Taunton within the archdeaconry of Taunton the parishes of Hatch Beauchamp and Beer Crocombe and the rural deanery of Bridgwater within the same archdeaconry.
(7) There shall be transferred to the rural deanery of Taunton the same archdeaconry and the parish of Broomfield now in the rural deanery of Bridgwater within the same archdeaconry.
