By Part III of the Second Schedule to the Land Drainage Act, 1930, it is provided that if any person aggrieved by an Order desires to question its validity on the ground that it is not within the powers of the Act or that any requirement of the Act has not been complied with, he may, within six weeks after the publication of this notice, make an application for the purpose to the High Court, and if any such application is duly made, the Court, if satisfied that the Order is not within the powers of the Act, or that the interests of the applicant have been substantially prejudiced by any requirements of the Act not having been complied with, may quash the Order either generally or in so far as it affects the applicant.

RIVER BOARDS ACT, 1948.

Trent River Board.

Finningley Internal Drainage District.

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has made an Order under the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, confirming a scheme submitted to him by the Trent River Board under Section 4 (1) (b) of the Land Drainage Act, 1930, making provision for the following matters:—

1. The amalgamation of the Misson Internal Drainage District and the Snow Sewer Drainage District to form an Internal Drainage District to be known as the Finningley Internal Drainage District.

2. The abolition of the Misson Internal Drainage Board and the Snow Sewer Drainage Board.

3. The constitution of an Internal Drainage Board for the Finningley Internal Drainage District.

4. Certain matters supplemental to or consequential on the matters aforesaid.

The Order will become final, and have effect as an Act of Parliament, unless within thirty-five days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall be subject to special parliamentary procedure.
