TITHE REDEMPTION COMMISSION.

TITHE ACTS, 1936 AND 1951.

Notice is given that the Treasury have fixed at 3½ per cent. as from the 9th May, 1955, and until further notice, the rate of interest to be adopted in discounting future payments in respect of instalments of an annuity charged by the Tithe Act, 1936, for the purpose of determining, in accordance with the Redemption Annuities (Extinguishment and Reduction) Rules, 1937, the amount of consideration money to be paid for the Redemption of the annuity.

On the basis of this rate of interest, the amount required to redeem an annuity is approximately 20½ times the amount of the annuity (or 41 times the amount of the half-yearly instalment).
