2547082 Staff Sergeant Kenneth Gerald Adex, Corps of Royal Electrical and Mechanical Engineers.

At 1430 hours on 5th October, 1954, a serious fire occurred in a storeroom containing petrol inside a garage, which housed a large number of vehicles in the lines of 5th Regiment Royal Horse Artillery, Mercer Barracks, Osnabruck.

The door of the storeroom was closed and the outbreak of the fire was discovered when a muffled explosion was heard from inside the room, immediately followed by a sheet of flame coming from underneath the door.

The alarm was given, the door kicked in and fire fighting arrangements put into effect. At this time, however, the soldiers in the garage were unaware that there were men inside the storeroom.

Hearing the alarm, Staff Sergeant Adey seized a fire extinguisher and ran towards the scene of the fire. On the way, he passed the barred windows of the storeroom and saw the faces of two or three men, who were, with the assistance of others outside, attempting to break the windows of the

storeroom.

With no thought for his personal safety Staff Sergeant Adey ran to the door, played his extinguisher on the flames, cleared a small path for himself, and although other parts of the room were still burning flercely and the room was still full of smoke and petrol fumes, went straight in and, unaided, carried three injured men to safety, and then, the flames having been brought more under control, assisted in bringing out a further two men. two men.

All were very severely burned and one, Number 14951059 Signalman F. R. Gardner, subsequently died.

Only after he was satisfied that there were no other soldiers in the store, did Staff Sergeant Adey allow himself to be taken out into the open air, where he collapsed from the effects of his

where he collapsed from the effects of his exertions and the petrol fumes.

Throughout there was a very real risk of further petrol explosions in addition to the fierce fire that was already burning. There is no doubt whatever that, but for Staff Sergeant Adey's immediate and most courageous action, the remaining men in the room would probably also have died from burns or sufficiation or suffocation.
