An extract relating to a Borough, Urban or Rural District—The office of the Town Clerk, the Clerk to the Urban or Rural District Council and the Clerks to the Bottesford, Kibworth Harcourt and Measham Parish Councils.

The owner, lessee or occupier of any land on which the said Map and Statement show a right of way may apply to the Appeals Committee of Quarter Sessions for a declaration that, at the relevant date (the 1st December, 1952)—

(a) there was no public right of way over the land;

(b) the rights of the public differed from those shown on the Map and Statement;

(c) the position or width of the public right of way differed from those given in the Map and Statement; or

(d) the public right of way was subject to limitations or conditions in addition to or different from those shown in the Map and Statement.

Any such application must be made in writing to the Clerk of the Peace, County Offices, Grey Friars, Leicester, and must reach him not later than the 24th June, 1955. The application must specify the land to which the application relates; the nature of the application and the grounds on which it is made, and the name of the surveying authority, which is the Leicester County Council. It would be appreciated if the reference letter and number of the right of way as shown on the Provisional Map were also given.

Within the same period, notice of any such application must be served upon any other owner, lessee or occupier of land affected by the application and upon the Clerk of the Leicester County Council, County Offices, Grey Friars, Leicester.

Applicants should consult the National Parks and Access to the Countryside Act, 1949, and the Public Rights of Way (Applications to Quarter Sessions) Regulations, 1952.

GLOUCESTERSHIRE COUNTY COUNCIL.

SCHEDULE.

In the Rural District of North Cotswold.

Parish of Adlestrop.

Add footpath from County Road near Daylesford School, proceeding south-west to join bridle road HAD 20 near the Oxford, Worcester and Wolverhampton railway.

Realign carriage road/bridle road HAD 19 at Hill Farm, Daylesford.

Parish of Aston Subedge.

Realign footpath (HAS 8) extending from parish boundary WSW of Burnt Norton to county road B.4035.

Parish of Bledington.

Add, as footpath extension to bridleway (HBL 2) from Bledington Heath to parish boundary.

Add extension to footpath HBL 3 from west of Bledington Heath to parish boundary.

Add footpath at north side of Westcote Brook connecting HBL 16 with HBL 10 and end portion of HBL 12.

Delete footpath (HBL 5) extending south-east then east from HBL 2 in Bledington Grounds to HBL 9, Heath Lane.

Delete part of bridleway (HBL 12) extending from Bledington Village to its junction with HBL 10.

Parish of Blockley.

Realign footpath (HBY 20) extending from south of Ditchford Farm to east of Manor Farm.

Realign footpath (HBY 23) extending from south of Upper Ditchford to east of Draycott House.

Delete footpath (HBY 55) extending south-east from HCC 53 at parish boundary near New Warren to HBY 65 south-east of Warren Cottages.

Delete footpath (HBY 66) extending south-west from HBY 55 to HCC 53 at parish boundary near Campden Ashes.

Parish of Bourton-on-the-Water.

Add footpath from CRB HBW 12 to the junction of footpaths HBW 13 and 33 south-east of Bury's Barn.

Add footpath from HBW 29 easterly and northerly to the Rissington Road west of Rissington Bridge.

Parish of Broadwell.

Delete footpath (HBR 5) extending from north-east of Kennel Cottages to west of Stock Bridge.

Parish of Chipping Campden.

Delete footpath (HCC 2) extending south-east of Dyers Lane to footpath HCC 13, Littleworth.

Delete footpath (HCC 6) extending from Route B.4035 north of Wold's End to north of St. James' Church.

Delete footpath (HCC 11) extending north of Castle Farm to Route B.4035 north of Station.

Delete footpath (HCC 49) extending north from Route A.44 to footpath HCC 24 west of Comb Buildings.

Delete carriage road/footway (HCC 51) extending south-west from Route A.44 to parish and county boundary at Diamond Jubilee Wood.

Delete footpath (HCC 52) extending south south-west from HCC 51 north-east of Diamond Jubilee Wood to parish and county boundary at Central Lodge.
