

Delete footpath (HCC 53) extending south-west and south from Route A.44 near Camp Hill Plantation to parish boundary to Lodge in the Dingle Plantation.

Delete footpath (HCC 55) extending west then north from HCC 53 at Campden Ashes to parish and county boundary.

Delete footpath (HCC 56) extending west from HCC 53 south of Campden Ashes to parish and county boundary east of Springfield House.

*Parish of Condicote.*

Delete footpath (HCO 1) leading to Sheepwash.

Delete bridleway (HCO 2) forming private drive to Sezincote.

Delete footpath (HCO 4) extending from Old Hinchwick to Hull Plantations.

Delete footpath (HCO 5) extending east from county road near Guitinghill Plantation to county road north-west of Glebe Farm.

Delete footpath (HCO 6) extending east from HCO 5 west of Glebe Farm to county road at St. Nicholas' Church.

*Parish of Cutsdean.*

Delete footpath (HCU 2) extending north-west from county road south-east of Halfmoon Lodge to bridleway HCU 1 at Welshman Hedge Plantation.

Delete footpath (HCU 3) extending west of Dirty Bridge to Upper Slatepits.

Delete footpath (HCU 4) extending from Hands Hill Plantation to west of Ling Ground.

Delete footpath (HCU 11) at western end towards Cutsdean Lodge.

*Parish of Ebrington.*

Add bridleway from Blackdowns Farm to Stretton-on-Fosse (portion in Gloucestershire).

Realign footpath (HEB 19) extending from Ebrington Hill to west of Vicarage.

Realign footpath (HEB 25) extending from north of Church to east north-east of Church.

*Parish of Great Rissington.*

Alter description of that part of way HRG 5 from county road west of Glebe Farm to gateway of Hemmings Ley Field from bridleway to carriage-road/bridleway.

Alter description of HRG 6 from east of Glebe Farm to east of Great Rissington Farm to bridleway.

*Parish of Guiting Power.*

Realign footpath (HGP 10) to follow the Avenue to the Church gate thence round to south side of Church and directly to second gate in north side of Church.

Delete footpath (HGP 9) extending from north-west of Hawling Lodge to east of Vicarage.

*Parish of Icomb.*

Delete footpath (HIC 4) extending west of School.

*Parish of Longborough.*

Realign footpath (HLO 1) from Orchard to Sezincote Hill to junction with HCO 3, to be shown on Sezincote side of parish boundary.

Delete footpath (HLO 2) extending south of Debdean to south of Luckley Farm.

Delete footpath (HLO 3) extending south of Luckley Farm.

Delete footpath (HLO 10) extending from west of Rookery to south of Banks Fee Farm.

*Parish of Maugersbury.*

Alter description of way (HMA 3) from county road A.429 west to HSU 20 at Hyde Mill parish boundary from footpath to bridleway.

*Parish of Mickleton.*

Delete footpath (HMN 2) extending from county road south-east of Norton Hall Cottages to footpath HMN 1 south-west of Prospect Gardens.

Delete footpath (HMN 3) extending from south-east of Norton Hall Cottages to county road A.46, north-west of Hillside.

Delete footpath (HMN 4) extending from south-east of Norton Hall Cottages to county road A.46.

Delete bridleway (HMN 6) extending south-west of Clopton to Cranbrook Lane.

Delete footpath (HMN 25) extending north-west of Ninevah to Route B.4081.

Delete part of footpath (HMN 37) from its junction with HMN 24 near Kiftgate Court, east then north to its junction with HMN 36 and HMN 38 near Mickleton Wood Cottages.

Delete footpath (HMN 39) extending from Mickleton Wood to Cranbrook Barn.

*Parish of Moreton-in-Marsh.*

Delete footpath (HMM 9) extending south from HMM 7 east of Upper Fields to HSE 17 parish boundary south-east of Upper Fields.

*Parish of Naunton.*

Add footpath from Lower Harford to road from Harford Bridge and Upper Slaughter.

Realign bridleway (HNA 18) from west of Lodge Barn to county road south of Lower Harford.

Delete footpath (HNA 10) north-west of Lodge Barn.

*Parish of Oddington.*

Add footpath from HBL 4 at parish boundary east of Lower Oddington Ashes proceeding north-west along Oddington parish boundary to join bridleway HOD 17 at the footbridge on the parish boundary between Oddington and Adlestrop Parishes.

Add footpath from bridleway (HOD 18) near Bledington Heath, extending south-west to parish boundary at Bledington Heath.

Delete footpath (HOD 10) extending from west of School to east of Methodist Chapel.

*Parish of Saintbury.*

Add footpath from St. Nicholas' Church to county road west of Gun's Cottages.

Delete footpath (HSA 4) from parish boundary near Cheltenham—Honeybourne railway line south-east to Route A.46.

*Parish of Sezincote.*

Add footpath from HLO 1 at parish boundary, west of Sezincote Hill to HLO 1 at parish boundary south-west of Hans Brake.

Delete footpath (HSE 2) extending north from the Warren to county road.

Delete footpath (HSE 3) extending north from HCO 1 at parish boundary to HSE 2 south of Warren Farm.

Delete footpath (HSE 5) extending north from Hinchwick to Blessed Bottom.

Delete bridleway (HSE 8) extending north-east from parish boundary at Staites Break to Tumble-down.

Delete bridleway (HSE 9) extending east north-east from Evesham—Stow Road to south-east of Home Farm.

Delete footpath (HSE 11) extending north-west from south-east of Home Farm to north-east of Home Farm.

Delete footpath (HSE 13) extending north from HSE 10 to the Lake.

Delete footpath (HSE 17) extending north and north-east from HSE 12 at Lower Rye Farm to HMM 9 at parish boundary.

*Parish of Lower Slaughter.*

Statement relating to HSL 4, 8, 10 and 11 be amended to record right to plough.

*Parish of Upper Slaughter.*

Alter description of way HSU 1 from Route A.436 east of Ryford Cottages to HSS 1 at Chalkhill from footpath to bridleway.

Alter description of way HSU 5 from Route A.436 as far as its junction with HSU 8 from footpath to bridleway. Remainder of HSU 5 to remain as footpath and to be renumbered HSU 8. Existing HSU 8 from its junction with HSU 5 to the School becomes HSU 5 and description altered from footpath to bridleway.

Alter description of way (HSU 20) from county road east of Fir Farm to parish boundary at Hide Mill from footpath to bridle road.

Delete footpath (HSU 2) extending from county road A.436 south-east of Rackcliffe in a northerly direction to the parish boundary west of Swell Hill Farm.

Delete footpath (HSU 13) from road, north-east to its junction with HSU 7 near Copse Hill.

*Parish of Stow-on-the-Wold.*

Delete bridleway (HSW 9) extending east from Well Lane to parish boundary north of Union Workhouse.

Delete footpath (HSW 11) extending north-east of Frog Wall to Route A.429.

*Parish of Swell.*

Add footpath from Fox Farm to St. Nicholas' Church.

Alter description of Way HSS 1 from county road at Chalkhill to HSU 1 at parish boundary from footpath to bridleway.
