

Delete footpath (HSS 2) extending from east of Chalkhill Cottages to route B.4077.

Delete footpath (HSS 3) extending south-east from county road at Barn Cottages to parish boundary at the "Covert".

Delete footpath (HSS 10) extending from Rectory Farm to parish boundary.

*Parish of Temple Guiting.*

Add footpath from HTG 3 at Cromwells Clump north of Parish and Rural District boundary east of Hailes Wood.

Add footpath from HTG 4 as continuation of HTG 3 north-west of Farmcote proceeding west along parish boundary to join additional footpath in Cheltenham Rural District south of St. Mary's Abbey, Hailes.

*Parish of Todenham.*

Alter description of footpath (HTO 2) extending south-west of High Firs to bridleway.

*Parish of Weston Subedge.*

Realign footpath (HWS 2) to run from parish boundary west of Poden in a westerly direction then north and west again to Route 3/115 south-west of St. Egwin's Church, Honeybourne.

Delete footpath (HWS 3) extending from its junction with HWS 4 north-east of Long Stretch Farm to county boundary.

Extend footpath HWS 4 from its junction with HWS 3, to Buckle Street.

*Parish of Willersey.*

Realign footpath (HWY 12) extending south then south-west from Route A.46 opposite the Field to parish and county boundary south-west of the Vineyard.

In the Rural District of Northleach.

*Parish of Aldsworth.*

Delete bridleway (KAL 1) from county road near Aldsworth School north to parish boundary near Allens Lodge.

Delete footpath (KAL 4) from county road north of Aldsworth War Memorial proceeding north-east to its junction with KAL 1 near Wall Farm.

Delete footpath (KAL 5) from county road near Aldsworth Vicarage north-east to its junction with bridle road KAL 1 near Wall Farm.

*Parish of Aston Blank.*

Add footpath from county road opposite Grove Farm proceeding south of KAB 9 west of the Keepers Arms public house.

*Parish of Chedworth.*

Delete footpath (KCH 27) from county road south-east of the Wagon & Horses Inn, Chedworth, proceeding east to its junction with KCH 26.

*Parish of Compton Abdale.*

Delete part of footpath (KCN 3) from its junction with KCN 2 west to county road south of Smallhope Cottages.

Delete footpath (KCN 5) from county road north-east of the Manor, Compton Abdale, proceeding south-east to county road 40876.

*Parish of Dowdeswell.*

Add footpath from parish boundary at Rough Hill Bank north-west to bridle road KDO 29 near Holly Grove, Pegglesworth.

Amend schedule for bridle road (KDO 29) to include the words "No Public Right exists to drive animals along this Bridle Road".

Delete footpath (KDO 9) from route A.40 south south-east to KDO 10 south-west of Andoversford Railway Station.

Delete footpath (KDO 28) from A.436 at Cold Comfort west south-west to KDO 29 near Pegglesworth Home Farm.

Delete bridle roads KDO 30 and KDO 31 and realign on the east side of boundary of Chatcombe Wood, within the Parish of Coberley, in the Rural District of Cheltenham.

*Parish of Hampnett.*

Add footpath from KYA 2a at parish boundary, Hangman's Stone, to join county road known as Salt Way.

*Parish of Notgrove.*

Realign footpath (KNO 8) at its south-eastern end at Notgrove Village.

*Parish of Sherbourne.*

Alter description of bridleway (KSH 3) from Haycroft Farm north via Haycroft Bottom to the county road near "The Fork" from bridleway to footpath.

Footpath KSH 11 to become a part of KSH 3 and Schedule to be amended accordingly.

Realign footpath (KSH 7) at Broadmoor Farm.

Delete part of bridle way (KSH 3) from county road near Duckleston Mill, north to its junction with footpath KSH 11 at Haycroft Farm.

Delete footpath (KSH 6) from county road near Broadmoor Cottages north-east to its junction with KSH 7 at Broadmoor Farm.

Delete footpath (KSH 8) from the county road near Northfield Barn, north-west to its junction with KSH 5 at Clark's Close.

Delete footpath (KSH 9) from county road near Northfield Barn south-west via Sheafhouse to county road near St. Mary's Church, Sherbourne.

Delete footpath (KSH 15) from county road near Bourton Lodge north-east across Allotment Gardens.

Delete bridleway (KSH 17) from Route A.40 south-west to Woeful Lake Farm.

Delete bridleway (KSH 18) from Woeful Lake Farm, south-east to parish boundary near Allens Lodge.

Delete footpath (KSH 19) from Woeful Lake Farm, north-east to county road near Viscount's Lodge.

Delete footpath (KSH 25) from county road south of Mareslaid Copse.

*Parish of Whittington.*

Add footpath from county road south-west of Wood Farm proceeding south-west to the Parish and Rural District boundary east of Colgate.

*Parish of Withington.*

Add footpath from parish boundary at Rough Hill Bank south-east to county road west of Pegglesworth Hill.

Amend schedule for bridle road KWG 13 to include the words "No Public Right exists to drive animals along this Bridle Road".

Delete part of bridleway (KWG 12) from county road near Rough Hill Bank, proceeding south-east to its junction with KWG 9 at Pegglesworth Hill.

Delete bridleway (KWG 32) from county road at Colnbrook proceeding south-west to its junction with bridle road KWG 36 near Postcombe.

In the Rural District of Tetbury.

*Parish of Beverston.*

Realign part of footpath (NBE 2) from Dursley—Tetbury road north to Beverston Old Brake.

Delete footpath (NBE 7) from its junction with Chavenage Lane south-west to its junction with NBE 5 near St. Mary's Church, Beverston.

Delete footpath (NBE 12) from its junction with NBE 7 south to its junction with NBE 5 at Castle Farm.

*Parish of Boxwell-with-Leighterton.*

Delete footpath (NBL 2) from Boxwell Road north to NKS 34 in the Nursery Wood.

*Parish of Cherington.*

Delete footpath (NCH 4) from county road near Parkers Hill Plantation north-east to county road east of Black Covert.

Delete footpath (NCH 5) from county road near Parkers Hill Plantation north-east to county road at Lowsmoor Farm.

Delete footpath (NCH 6) from county road at Lowsmoor Covert south-east to county road east of Lowsmoor Farm.

*Parish of Kingscote.*

Add footpath from county road at Hazelcote Barn north-west to footpath NKS 15 near Hazelcote Farm.

*Parish of Long Newnton.*

Delete footpath (NLN 15) from Ham Cottages north-west to Tetbury—Malmesbury Road, route A.434, near Cottage Hospital.

Delete footpath (NLN 16) from NLN 17 south-east of Slad's Farm west to parish boundary at Grange Farm.

Delete carriage road/footway (NLN 17) from route A.434 at Newnton Lodge south-west to parish boundary at Estcourt Park.

*Parish of Shipton Moyne.*

Amend part of carriage road/footway (NSM 19) from its junction with NSM 20 to its junction with NSM 17 to footpath.
