2. An Order under section 14 of the Special Roads Act, 1949, the effect of which is to provide for the re-aligning and re-grading of a length of Waterslade Road, The Broadway and Dovecot Lane, at Yaxley, from their junction with the new trunk road.

Any person aggrieved by either of the said Orders and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Trunk Roads Act, 1946 as amended by the Special Roads Act, 1949, or, as the case may be, of the Special Roads Act, 1949, or on the ground that any requirement of these Acts, or of any regulations made thereunder, have not been complied with in relation to the Order, may, within six weeks of the 2nd day of June, 1955, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.

##### ONE-WAY TRAFFIC WORKING—ST. JAMES'S SQUARE, CITY OF WESTMINSTER.

The Minister of Transport and Civil Aviation in accordance with the London Traffic Act, 1924, s. 10, as amended by the London Passenger Transport Act, 1933, s. 63, proposes to refer to the London and Home Counties Traffic Advisory Committee for their advice and report a proposal that he should make Regulations to institute one-way traffic working (a) from south-east to north-west in the link road lying between the south-western corner of St. James's Square and Pall Mall, and (b) from north-west to south-east in the link road lying between the north-eastern corner of St. James's Square and Pall Mall, in the City of Westminster.

Objections to the making of such Regulations may be sent to the Secretary, Ministry of Transport and Civil Aviation, 21-37, Hereford Road, London, W.2, not later than 17th June, 1955.
