DANGEROUS DRUGS REGULATIONS, 1953.

SUSPENSION OF WITHDRAWAL OF AUTHORITIES.

(Brendan O'Carroll.)

Whereas the authorities respectively conferred by the Dangerous Drugs Regulations, 1937, and the Raw Opium etc. Regulations, 1937, on Brendan O'Carroll, L.A.H. Dublin, by virtue of his being a duly qualified medical practitioner to be in possession of and to supply the drugs and preparations to which those Regulations applied were, the said Brendan O'Carroll having been convicted of offences against the Dangerous Drugs Acts, 1920 to 1932, withdrawn in pursuance of the powers conferred on the Secretary of State by Regulation 7 of the first mentioned Regulations and Regulation 5 of the last mentioned Regulations by Notices published in the London Gazette and the Edinburgh Gazette on the 9th day of December, 1947, the registered address of the said Brendan O'Carroll being then 50, Qnslow Square, South Kensington, London, S.W.7:

And whereas at the same time the Secretary of State directed under the said Regulation 7 that it should not be lawful for the said Brendan O'Carroll to give prescriptions for the purposes of the Dangerous Drugs Regulations, 1937:

And whereas by virtue of Regulations 29 and 38 of the Dangerous Drugs Regulations, 1953, the Secretary of State is empowered at any time to restore such an authority as aforesaid which has been withdrawn under either of the said Regulations of 1937, or to suspend such a withdrawal:

And whereas I am satisfied that it is expedient to suspend the aforesaid withdrawal of authorities from the said Brendan O'Carroll:

Now, therefore, I hereby suspend, in pursuance of the powers conferred upon me by Regulations 29 and 38 of the Dangerous Drugs Regulations, 1953, the aforesaid withdrawal of authorities from the said Brendan O'Carroll, and I further suspend the operation of the said direction regarding prescriptions given in respect of the said Brendan O'Carroll.

RETAIL DRAPERY, OUTFITTING AND FOOTWEAR TRADES WAGES COUNCIL (GREAT BRITAIN).

(16)) as amended by the Retail Drapery, Outfitting and Footwear Trades Wages Council (Great Britain) Wages Regulation (Amendment) Order, 1955 (Order R.D.O. (20)) and (2) for the same amendment to the Retail Drapery, Outfitting and Footwear Trades Wages Council (Great Britain) Wages Regulation (Holidays) Order, 1949 (Order R.D.O. (4)) as amended by Order R.D.O. (16) and Order R.D.O. (20).
