Development Plan.

NOTICE is hereby given that on the 30th day of July, 1955, the Minister of Housing and Local Government approved with modifications the above Development Plan.

COUNTY PALATINE OF CHESTER.

TOWN AND COUNTRY PLANNING ACT, 1947.

Town and Country Planning (Control of Advertisements) Regulations, 1948.

The County Palatine of Chester (Areas of Special Control) Order, 1955.

NOTICE is hereby given that the Cheshire County Council in exercise of their powers under Regulation 10 of the Town and Country Planning (Control of Advertisements) Regulations, 1948, have submitted for the approval of the Minister of Housing and Local Government an Order defining as areas of special control for the purpose of the said Regulations areas of land situate within the county of Chester and broadly indicated in Schedule "A" hereto, which land is shown coloured green on the map in twelve sections accompanying the Order, and that the Order is about to be considered by the Minister.

A copy of the Order and of the map referred to and of the statement of reasons submitted therewith have been deposited at each of the offices mentioned in Schedule "B" hereto and will be open for inspection without payment of fee between the hours of 9.30 a.m. and 4.30 p.m. on Mondays to Fridays and between 9.30 a.m. and 12 noon on Saturdays.

A copy of the Order and of the statement above referred to and the relevant section or sections of the map relating to the district concerned will also be available for inspection at the office of each Borough, Urban District and Rural District Council affected during their usual office hours.

Any objection to the Order must be made in writing, stating the grounds of the objection, and addressed to the Secretary, Ministry of Housing and Local Government, Whitehall, London, S.W.1, before the 10th day of September, 1955. A copy of any such objection should be sent to me at the same time.

Within the Runcorn R.D.—Appleton, Frodsham, Grappenhall, Halton, Helsby, Kingsley, Stockton Heath, Stretton, Sutton and Thelwall.

Within the Tarvin R.D.—Beeston, Kelsall, Malpas, Tarvin, Tattenhall, Tiverton and Waverton.

Within the Tintwistle R.D.—Tintwistle.
