REGULATIONS FOR THE RECRUITMENT BY OPEN COM-PETITION OF LEGAL ASSISTANTS (ENGLAND) IN THE HOME CIVIL SERVICE.

Candidates must be at least 26 and under 40 years of age on 1st October of the year in which the

competition is held, except that

(i) a candidate who has served or is serving on a regular (including a regular short-service) engagement in H.M. Forces may deduct from his actual age the period of such service rendered before 1st October of the year in which the competition is held; and

(ii) on this occasion candidates over the age of 40 on the 1st October, 1955, will be admitted to the competition if they have had at least three years' temporary service in a legal post in a Government Department immediately prior to 1st October, 1955.

2. Sex and Marriage.
(i) Both men and women may compete under these

Regulations.

(ii) Married women who have formerly been established civil servants and have drawn marriage gratuity (other than those who resigned compulsorily on marriage and whose resignation took effect before 15th October, 1946, or who are widows or divorced, or who are separated from their husbands, or whose

husbands suffer without hope of recovery from total physical or mental incapacity) will not be eligible unless they undertake to refund on appointment the marriage gratuity paid. Provided that this undertaking will not be required if the break between the first period of service (including any period of unestablished service immediately following the period in respect of which the gratuity was paid) and the date of re-establishment is more than seven years.

3. Nationality.
