"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and now humbly lay before Your Majesty in Council the following Scheme for altering the boundaries of the parishes of Great Stanmore and Little Stanmore both in the diocese of London.

"Whereas we are satisfied that it is desirable that the boundaries of the said parishes should be altered in the manner hereinafter mentioned:

and Honeypot Lane) to the boundary which divides the parish of Great Stanmore from the parishes of All Saints, Queensbury and Saint Anselm, Belmont."

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Righ Reverend Percy, Bishop of Norwich (in witness whereof he has signed the Scheme) for effecting the disuming of the united the Scheme), for effecting the disunion of the united benefice of Bradfield with Swafield in the diocese of Norwich.

"Whereas by an Order of His late Majesty King George the Fifth in Council dated the 21st day of December, 1917, and published in the London Gazette on that day the benefice of Bradfield and the benefice of Swafield were united into one benefice with cure of souls:

"And whereas the Bishop of the said diocese of Norwich has forwarded to us provisional proposals pursuant to the said Pastoral Reorganisation Measure. 1949, recommending that the union of the said benefices should be dissolved and that the said benefice of Bradfield should be held in plurality with the benefice of Antingham with Thorpe Market, and that the said benefice of Swafield should be held in plurality with the benefice of Trunch, all of which benefices are in the said diocese of Norwich:

"And whereas effect can be given to the said proposals so far as they relate to the dissolution of the said union by Scheme prepared by us and confirmed by Order of Your Majesty in Council pursuant to the said Union of Benefices Measures, and in so far as they relate to the said pluralities by subsequent Orders made by the said Bishop pursuant to the said Pastoral Reorganisation Measure." Measure:

"Now, therefore, we do humbly recommend and propose to Your Majesty in Council as follows, that is to say:-

"1. Disunion of benefices.
"The union of the benefice of Bradfield and the benefice of Swafield in the said united benefice of Bradfield with Swafield shall be dissolved and the said benefices shall thereupon each become a separate benefice with cure of souls within the limits of its separate parish.

"2. Taking effect of disunuon.
"The disunion of the said united benefice shall take effect upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette.

"3. Parsonage house.

"The parsonage house of the said united benefice shall belong to and be the parsonage house of the separate benefice of Swafield.
