Nene River Board.

Holland Elloe Internal Drainage District.

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has made an Order under the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, confirming a Scheme submitted to him by the Nene River Board under section 4 (1) (b) of the Land Drainage Act, 1930, making provision for the following matters:—

1. The alteration of the boundaries of the Holland Elloe Internal Drainage District by the inclusion therein of the land known as the Gedney Enclosure.

2. Matters supplemental thereto or consequential thereon.

The Scheme affects land in the Parish of Gedney.

The Order will become final, and have effect as an Act of Parliament unless within thirty-five days from the date of this Notice a memorial is presented to the Minister by some person or body affected and having an interest sufficient for the presentation of a memorial, praying that the Order shall be subject to special parliamentary procedure.

DISEASES OF ANIMALS ACT, 1950.

Notice is hereby given in pursuance of Section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland acting jointly have made the following Order:—

Statutory Instruments 1955 No. 1696.

The Live Poultry (Mid Lancashire) Order, 1955
(Made 8th November, 1955).

This Order, which came into operation on 12th November, 1955, prohibits the movement of live poultry into, out of and within the area in Lancashire specified in the First Schedule. The holding of markets of store poultry and exhibitions of poultry for show purposes in the said area is also prohibited. Poultry intended for immediate slaughter may, however, be moved within the area if accompanied by a licence issued by the Local Authority and provided the tail feathers of the birds are clipped back in the manner prescribed in the licence.
