"3. Distribution of the endowments and property of the benefice of Tatham and Tatham Fells.

"Upon the taking effect of the unions hereinbefore recommended and proposed, (a) a capital sum sufficient to produce an annual income of £272 8s. 2d. and being part of a larger capital sum held by us for the endowment of the benefice of Tatham and Tatham Fells, and (b) all that part of the glebe land at present belonging to the benefice of Tatham and Tatham Fells which is situated in the parish of Tatham Fells shall be annexed to the benefice of Tatham Fells and shall become part of the endowments and property of the united benefice of Wray with Tatham Fells, and all other the endowments and property of the benefice of Tatham and Tatham Fells shall be annexed to the benefice of Tatham and shall become part of the endowments and property of the united benefice of Tatham and shall become part of the endowments and property of the united benefice of Melling with Tatham.

"4. Alteration of parochial boundaries.
"Upon the union taking effect all that part of the parish of Tatham which is described in the Schedule hereto shall be severed from that parish and annexed to the parish of Wray.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 9th day of November, 1955, in the words and figures following, that is to

"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Andover with Foxcott and Abbotts Ann in the diocese of Winchester

"SCHEME.

"Whereas we, the Church Commissioners, satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting

hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Alwyn, Bishop of Winchester (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme) we the said Church Commisseal to this Scheme), we the said Church Commissioners do humbly recommend and propose as follows, that is to say:—

"1. Constitution.

- "(a) As from the date of the licence thereto of a minister, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be a separate district for spiritual purposes.
- "(b) As from the date of the consecration of a church within the area, approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.
- "(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Michael and All Angels, Andover'.

2. Archdeaconry and Rural Deanery.

"The parish shall be in the Archdeaconry of Basingstoke and in the rural deanery of Andover.
