No. 32. F.P. Junction with B.R.40 approx. 550 yards S.W. of Little Bayhall proceeding S.E. to County boundary approx. 550 yards N. of Sunninglye.

No. 52. F.P. High Rocks Lane under railway and through Friezland Wood to County boundary.

No. 90. F.P. Reynolds Lane by Caenwood Farm N. to Speldhurst Road opposite junction with Kibbles Lane.

No. 98. F.P. and road used as public path (C.R.F.) High Rocks Lane S. over railway skirting W. side of Three Acre Wood and passing N. and E. of Ramslye Farm to County boundary.

No. 78. F.P. Urban District boundary near Mabledon Farm E. by Streamlands to Vauxhall Lane at Little Rook Wood.

No. 99. F.P. From F.P.81 E. to Hospital in Old Furze Wood.

Penshurst Parish.

No. 45. F.P. Through Bowens Farm and E. to join Bidborough F.P.9 (also deleted) leading to Barden Furnace Farm.

No. 46. F.P. A short distance N. of the Mill House, Pounds Bridge, and proceeding E.N.E. to join Bidborough F.P.8 (also deleted) leading by Petersbank to Penshurst Road, B 2176.

Tonbridge Rural District.

Bidborough Parish.

No. 4 (part). F.P. Hayesden Lane to junction with F.P.5.

No. 8. F.P. Penshurst Road, B 2176, S. by Petersbank to join Penshurst F.P.46 (also deleted) leading to Class III road a short distance N. of Mill House, Poundsbridge.

No. 9. F.P. Barden Furnace Farm W.S.W. to join Penshurst F.P.45 (also deleted) leading to Class III road at Bowens Farm.

No. 14 (part). F.P. From Bidborough Street E.S.E. to entrance to Council houses.

Brenchley Parish.

No. 7. F.P. Junction with F.P.6 at Chowning Green leading S.S.W. and W. to junction with F.P.4 approx. 100 yards N. of Crittenden Road.

No. 73 (part). F.P. (a) opposite Church S.E. to junction with route 76 at Hononton, (b) junction with route 75 at Hononton E. to Furnace Road.

No. 74. F.P. Little Cowden N.E. to junction with deleted part of F.P.73.

No. 97 (part). F.P. Spout Lane N.E. and N. through Cork Wood to junction with F.P.98.

No. 100. F.P. Spout Lane approx. 100 yards S.W. of Tawsden, E.S.E. through Flightshot and N.E. to Burr's Hill.

Capel Parish.

No. 1. F.P. Commences approx. 230 yards S.E. of Tonbridge Urban District boundary near the Postern and leads S.W. to N. side of railway.

No. 8. F.P. Junction with F.P.6 approx. 220 yards E. of Somerhill, S.E. to junction with F.P.9 at Knowles Bank.

No. 18. F.P. Five Oak Green Road, B 2017, W. of Five Oak Green N.W. through Finches Farm and across railway for approx. 300 yards to meet F.P.17.

Hadlow Parish.

No. 13 (part). F.P. Tonbridge Urban District boundary approx. 500 feet S. of Three Elm Lane leading through Gammon's Land by Hadlow Place to junction with F.P.15 W. of Thompson's Farm.

No. 14. F.P. Gammon's Land N. to Three Elm Lane.

No. 16. F.P. Hartlake Road at Thompson's Farm leading W. to junction with deleted part of F.P.13.

No. 20. F.P. Junction with F.P.19 immediately W. of Hartlake Road near Hartlake Farm and leading S.W. to River Medway towing path.

No. 21. F.P. Hartlake Bridge and leading N.W. for approx. 333 yards to junction of F.P.'s 18A and 19.

No. 47. F.P. Junction with F.P.46 immediately N. of Carpenters Lane and leading N.E. to West Peckham Parish boundary in Oxen Hoath Park.

No. 48. F.J. Junction with F.P.47 in Oxen Hoath Park leading E. by Park Farm to Matthews Lane.

No. 63 (part). Road used as public path (C.R.B.). From A 227 along S. boundary of Sawpit Wood and then N.E. to point S.W. of Shooting Lodge where the route turns in a N.W. direction.

Paddock Wood (formerly Brenchley) Parish.

No. 2 (part). F.P. Approx. 200 feet S. of Mount Pleasant Road and leading S., S.E. and E. to B 2160 near Paddock Wood House.

No. 52 (part). F.P. Between the fences of the railway at Queen Street.

Speldhurst Parish.

No. 2 (part). F.P. The section which passes over the railway Station Approach.

No. 13. F.P. Ashurst Road, B 2110, 166 yards W. of B 2188 leading N. through Ashurst Park to junction with F.P.12.

No. 17A. F.P. A 264 immediately N. of Stone Cottages and leading in S.E. direction past Barn Field Plantation to junction with F.P.17 at Pokehill.

SECOND SCHEDULE.

Rights of Way Added.

Tunbridge Wells Borough.

F.P. Little Bayhall Farm N.W. through Rankham Wood to Cornford Lane.

F.P. Hawkenbury Road S. by Tutty's Farm to junction with F.P.44.

Southborough Urban District.

F.P. Extension of F.P.37 slightly in E. direction to meet N. end of Vale Road.

Tonbridge Rural District.

Hadlow Parish. F.P. Connecting Victoria Road N. of Hayse Farm with F.P.30 N.E. of Bournside.

Hadlow Parish. B.R. From route 63 S.W. of Shooting Lodge E. to Claygate Road near Oakdene. Hildenborough Parish. F.P. From Nizels Road opposite Nizels Farm through Irons Wood and under railway bridge to connect with Leigh Parish F.P.7.

THIRD SCHEDULE.

Variation of Routes.

Tonbridge Rural District—Hadlow Parish.

No. 18A. F.P. Instead of proceeding E. and S. from junction with F.P.18 near Hadlow Place, to proceed S.E. from such junction to junction with F.P.15.

No. 49. F.P. Instead of turning N.N.W. to join F.P.48, the northern part to bear N.E. and then E. to join Matthew's Lane, S. of Park Farm.

No. 60. F.P. After proceeding along the north side of O.S. No. 137 and the first few yards of O.S. No. 136 the path to turn N.W. through Frith Wood to Clearhedges Wood and then proceed along the Parliamentary Division and Rural District boundary until it meets Hook Wood Orchard. (O.S. No. 126.)

FOURTH SCHEDULE.

Change of Designation.

Southborough Urban District.

No. 10 (part). Road used as public path (C.R.F.) to F.P. From Ivy House Farm E. for approx. 233 yards.

No. 15 (part). Road used as public path (C.R.F.) to F.P. A section approx. 35 yards in length at the Colebrook Road end of this route which runs from near S.E. end of Welbeck Avenue to Colebrook Road.

Malling Rural District.

Shipbourne Parish. No. 8. Road used as public path (C.R.B.) to B.R. A 227 at Woodhall Cottage leading S.E. through Point Wood and Kiln Wood to the Hadlow Parish boundary approx. 360 yards N.N.E. of Dene Park Farm.
