### DESTRUCTIVE INSECTS AND PESTS ACTS, 1877 TO 1927.

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has made an Order under the Destructive Insects and Pests Acts, 1877 to 1927, entitled "The Wart Disease of Potatoes (Protected Area) (General Licence) Order, 1956".

This Order relaxes for the period 26th January, 1956 to 31st December, 1956 (both dates inclusive) the requirements of the Wart Disease of Potatoes Order, 1941, by authorising the planting or sale for planting within the Protected Area defined in the 1941 Order of seed potatoes obtained from crops grown in that area in 1955 which were not themselves the subject of a prescribed certificate but were grown from certified stocks.
