

Parish of Seenc. On O.S. 31/96.

- (2) Delete FP No. 19, from the Melksham Without boundary S.E. of Soho Farm, S.E. to the Canal Towing path.
- (5) Delete FP No. 32, from the Bromham Road opposite Berhills Farm, S.E. and S.W. across the Railway to Martinslade.
- (7) Add FP from road A.361 at its junction with path No. 12, N.W. in continuation of path No. 10A Pelch Lane.
- (8) (a) Alteration of course of FP No. 6 through the fence N.N.E. of Pile Cottage Gardens, and not through the Gardens.
- (b) Alteration of course of FP No. 29 immediately to the east of the western boundary of Pile Cottage Gardens.
- (9) Add FP from the N. end of path No. 35, E.N.E. along S. edge of Broad Lane to the road at Broad Lane Farm.

Parish of Stanton St. Bernard. On O.S. 41/06.

- (1) Add FP from All Cannings path No. 31, S. along the parish boundary, then S.E. and S. to the Horton—Pewsey road.
- (2) Add CRB from All Cannings path No. 31, N.E. to the Wansdyke at Tan Hill.

- (1) Alteration of course of path No. 10 at its southern end to lead past Manor Farm to west end of spur road U/C 7060.

- (1) Add FP from Crookwood Lane, 430 yards E. of the Railway, N. to FP No. 15.
- (2) Add FP from path No. 40, S. outside the western boundary of the churchyard to the road.
- (3) Add FP School Lane, from the road N. of the School, N.E. to the road.
- (4) Add FP from path No. 34, N. and N.E. along the accommodation cart track to Crookwood Lane E. of Crookwood Farm.
- (5) Add FP from the road at the N. end of the village at its junction with path No. 7, N. to path No. 16.

- (1) Delete northern section of FP No. 2, from BR No. 5 to the railway goods yard.

 - (b) Add CRB from Rickbarton U/C 7103 leading S. to CRB No. 34 at point deleted in (a) above.
- (3) Alter course of FP No. 11 from its east end to lead S.W. from path No. 9 to the Old Cheverell Road.
- (4) Add FP from path No. 15 opposite Dog Kennel Lane (path No. 14) E. to path No. 18.
- (5) Alteration of course of FP No. 28:—
 - (a) Delete path from path No. 27, 100 yards N. of Periwinkle Pond, W. to path No. 18.
 - (b) Add path from path No. 18, 65 yards N. of Duck Street, leading E. to path No. 27, just N. of Periwinkle Pond.
- (7) Delete CRB No. 33, Old Lavington to Imber track from S. end of road U/C 7105, S.W. past Lowland Farm and Bush Farm, then W. and S.W. to the Old Coaching Road.
- (10) Delete CRB No. 38, from path No. 32 at the Limekiln S.E. across the Ridge Way, through Brazen Bottom Farm and New Copse Farm to the Market Lavington boundary. (See Market Lavington Item No. (4).)

DEVON COUNTY COUNCIL.

Crediton Urban District.

NOTICE is hereby given that the Devon County Council, in exercise of the powers conferred on them by sub-section (3) of section 29 of the National

Parks and Access to the Countryside Act, 1949, have determined to modify the particulars contained in the Draft Rights of Way Map and Statement prepared under section 27 of the above-mentioned Act in relation to the rights of way in the Crediton Urban District within the area of the said Council as follows:—

(1) By the deletion of a public path being Footpath No. 21 which starts from the junction with Path No. 20 at Kersford Bridge and proceeds north to a field gate opposite Wellparks Farm where it joins the Exeter—Crediton Road (A.377).

(2) By the deletion of that portion of a public path being Footpath No. 28 which runs along the southern boundaries of O.S. Nos. 301, 285 and 282 and by substituting therefor a public path along the northern boundaries of O.S. Nos. 284 and 283 to join Footpath No. 19 on the corner of Bullmarsh Lane. That portion of the path lying between O.S. Nos. 302 and 284 is now impassable owing to erosion by the River Yeo for a distance of 50 yards approximately.

These paths are shown on a map which has been deposited at the respective offices of the Clerk of the County Council at The Castle, Exeter, and the Clerk of the Urban District Council at Crediton, and may be seen there free of charge during the usual office hours.

Any representation or objection with respect to this determination shall be made in writing addressed to the Clerk of the County Council, The Castle, Exeter, before the 29th day of February, 1956, and shall state the grounds on which it is made.

RURAL DISTRICT COUNCIL OF DAVENTRY.

Daventry Rural District Council (West Haddon No. 1) Extinguishment Order.

NOTICE is hereby given that the above Order was made on the 3rd day of January, 1956, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the Parish of West Haddon in the County of Northampton.

The effect of the Order will be to extinguish the public right of way leading from a point immediately adjoining the rear garden fence of No. 9, Elizabeth Road, West Haddon, situate in field Ordnance No. 168 on the Ordnance Survey Plan (1900 Edition) for the Parish of West Haddon to a point in the eastern corner of field Ordnance No. 135 and from the latter point branching (a) in a north easterly direction for a distance of approximately 53 yards and (b) in a south easterly direction for a distance of approximately 57 yards as shown coloured brown on the map annexed to the said Order.

A certified copy of the Order and of the map contained in the Order has been deposited at the Rural District Council Offices, Church Walk, Daventry, and will be open for inspection free of charge between the hours of 10 a.m. and 4.30 p.m. on weekdays, except Saturdays, and on Saturdays between the hours of 10 a.m. and 12 noon.

Compensation for depreciation or damage in consequence of the coming into operation of this Order is payable in accordance with Section 46 of the above Act, to which reference should be made.

Any objection or representation with reference to the Order may be sent in writing to the Secretary, Ministry of Housing and Local Government, Whitehall, London, S.W.1, before the 29th day of February, 1956, and any such objection or representation should state the grounds on which it is made.
