Notice is hereby given in pursuance of section 85 (3) of the Diseases of Animals Act, 1950, that the Minister of Agriculture, Fisheries and Food and the Secretary of State for Scotland acting jointly have made the following Order:—

The Live Poultry (Essex) (Revocation) Order, 1956
(made 22nd March, 1956).

This Order, which came into operation on 24th March, 1956, revokes two Orders which prohibited the movement of poultry into, out of or within a specified area of Essex.

Statutory Instruments 1956 No. 442.

The Foot-and-Mouth Disease (Infected Areas) Special Order, No. 7, 1956 (made 23rd March, 1956).

Contracts, as from 28th March, 1956, the Foot-and-Mouth Disease Infected Area around South Cadbury, Somerset, declared by Special Order No. 3, 1956, to an area comprising the districts situate within approximately 5 miles of South Cadbury.

Releases such contracted Infected Area from restrictions on 4th April, 1956.

Declares, as from 28th March, 1956, Foot-and-Mouth Disease Infected Area around East Stour, Dorset, which replaces the Foot-and-Mouth Disease Infected Area around West Tisbury, Wiltshire, declared by Special Order No. 2, 1956 and amended by Special Orders Nos. 5 and 6, 1956.

Releases such Infected Area from restrictions on 4th April, 1956.

Lincolnshire River Board.

Skegness District Internal Drainage District.

Notice is hereby given that the Minister of Agriculture, Fisheries and Food has now confirmed the Order made on the 23rd February, 1956, confirming, with modifications, the Scheme submitted to him by the Lincolnshire River Board under section 4 (1) (b) of the Land Drainage Act, 1930, as applied by the River Boards Act, 1948, making provision for the following matters:—

(1) The alteration of the boundaries of the Skegness District Internal Drainage District.

(2) Matters supplemental thereto or consequential thereon.

The Scheme affects lands in the Parish of Wainfleet St. Mary in the County of Lincoln (Parts of Lindsey).

having been complied with, may quash the Order either generally or in so far as it affects the applicant.

Wingland Internal Drainage District.
