TRUNK ROADS ACT, 1946.

SPECIAL ROADS ACT, 1949.

Five Lanes Junction, near Caerwent, Improvements.

The Minister of Transport and Civil Aviation hereby gives notice that he proposes to make an Order under section 14 of the Special Roads Act, 1949, the effect of which will be:—

(a) to provide for the re-alignment and regrading of a length of Blackpool Hall Road at Five Lanes Junction near Caerwent in the County of Monmouth which extends from its junction with the London—Fishguard Trunk Road in a northerly direction for a distance of approximately 33 yards;

(b) to provide for the construction by the Minister of a new road from a point on the said Trunk Road at Five Lanes Junction aforesaid approximately 60 yards west of its junction with Carrow Road in a southerly direction for a distance of approximately 33 yards;

(c) to provide for the stopping up of that length of Carrow Road at Five Lanes Junction aforesaid which extends from its junction with the said Trunk Road in a southerly direction for a distance of approximately 27 yards;

(d) that the Monmouthshire County Council will become the highway authority for the new road on the date on which notice is given by the Minister to the Council that the new road is opened for through traffic.

Copies of the draft Order and the relevant plan may be inspected free of charge at all reasonable hours from 11th May, 1956, to 9th August, 1956 at the offices of the Ministry of Transport and Civil Aviation, 21-37, Hereford Road, London, W.2, or Graham Buildings, Newport Road, Cardiff, the Monmouthshire County Council, County Hall, Newport, Mon., or the Post Office, Penhow, Newport, Mon.

Any person may within three months from 11th May, 1956, object to the making of the Order by notice to the Minister quoting reference HT 17/26/04 and stating the grounds of objection.

*West Cromwell Road Extension, Airedale Avenue
to British Grove, Improvements.*

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under section 14 of the Special Roads Act, 1949, the effect of which is:—

(a) to provide for the improvement of Netheravon Road at Chiswick, in the County of Middlesex, by regrading a length of its carriage-way;

(b) to provide for the construction by the Minister of three new roads as follows:—two of the new roads to extend from points on Netheravon Road on the north and south sides respectively of the route of the West Cromwell Road Extension to join British Grove; the third new road to extend from a point on Airedale Avenue at its junction with the northern side of the route of the West Cromwell Road Extension to form a turning place for traffic;

(c) to provide for the stopping up of those parts of Airedale Avenue and British Grove which form their respective junctions with the route of the West Cromwell Road Extension and that part of Netheravon Road which forms its northern junction with the said route;

(d) that the Brentford and Chiswick Borough Council will become the highway authority for the new roads on the date on which notice is given by the Minister to the Council that the new roads are opened for traffic.

Copies of the Order and of the relevant plan have been deposited at the Ministry of Transport and Civil Aviation, 21-37, Hereford Road, London, W.2,

and at the offices of the Brentford and Chiswick Borough Council, Town Hall, Chiswick, W.4, and may be seen at all reasonable hours.

Copies of the Order, the title of which is "The London—Bristol Trunk Road (West Cromwell Road Extension, Airedale Avenue to British Grove, Improvements) Order, 1956", can be obtained from the Ministry of Transport and Civil Aviation, Stationery Section, Berkeley Square House, London, W.1.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the grounds that it is not within the powers of the Special Roads Act, 1949, or on the ground that any requirement of that Act, or of regulations made thereunder, has not been complied with in relation to the Order, may, within six weeks of the 11th day of May, 1956, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
