(3) from the south western corner of parcel number 59 on Ordnance Survey Sheet Oxon L.2 (1921 Edition) in a north easterly direction across land owned by R. Roadnight and W. Milton Harris through parcels numbered 59, 61 and 150 to join footpath number 13 in the Parish of Watlington, all which rights of way are shown on the deposited maps and marked L-M, M-N and N-O.
