PRESENT.

The QUEEN's Most Excellent Majesty in Council.

WHEREAS the Minister of Housing and Local Government, after giving to the Incumbent and Churchwardens of the Parish of Stone, in the County of Kent, 10 days' previous notice of his intention in that behalf, has, under the provisions of the Burial Act, 1853, as amended by subsequent enactments, made a Representation to Her Majesty in Council that, for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Stone in the said County of Kent, save with the previous approval of the Minister of Housing and Local Government, should be prohibited, and that burials should be discontinued therein as follows, viz.:—

Stone.—Forthwith and entirely in the Church-yard of St. Mary's Church, Stone, in the said Parish.

Provided that-

In the earthen grave now existing in the said Churchyard in which the remains of George Prebble are interred, the burial may be allowed at her decease of the body of Alice Maria Prebble, subject however to the condition that no part of the coffin containing the body shall be at a less depth than three feet below the level of the surface of the ground.

Now, therefore, Her Majesty in Council is pleased hereby to give Notice of such Representation and to order that the same be taken into consideration by a Committee of the Privy Council on the 20th day

of October next.

And Her Majesty is further pleased to direct that this Order be forthwith published in the London Gazette, and that copies thereof be affixed on the doors of the Churches or Chapels of, or on some conspicuous places within the Parish affected by such Representation one month before the said 20th day of October.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 16th day of August, 1956, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Chislehurst Saint Paul's Cray and Saint Mary Cray. in the diocese Saint Paul's Cray and Saint Mary Cray, in the diocese of Rochester.

" SCHEME.

"Whereas we, the Church Commissioners, satisfied that the spiritual interests of the area defined in the Schedule hereto and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas we have not approved any con-

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Christopher, Bishop of Rochester (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:

"(a) As from the date of the licence thereto of a Minister the area defined in the Schedule hereto and delineated on the map hereto annexed shall be a separate district for spiritual purposes.

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church, or if the church is consecrated before such approval, the date of the approval, the said area shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Barnabas, Saint Paul's Cray'.

"The parish shall be in the Archdeaconry of Bromley and in the rural deanery of Chislehurst.

"THE SCHEDULE.

"(a) All that part (coloured pink on the map annexed hereto) of the parish of Chislehurst which lies to the east of a continuous imaginary line which commences at a point on the boundary which divides the parish of Chislehurst from the parish of Saint John, Sideup in the middle of the Sideup By-Pass Road in a straight line opposite the northern end of the western boundary of close number 151a and continues thence southwards to and along the western boundaries of the said number 151a and continues thence southwards to and along the western boundaries of the said close (thereby crossing closes numbered 151b, 136b and 136a) and closes numbered 151 and 182 westerly along the southern boundary of close number 181 the northwestern and western boundaries of close number 161 the northwestern boundary of close number 168, and in a straight line to the northeast boundary of close number 159 thence along the northeast, northwest and western boundaries of the said close number 151 westwards and southwards along the northern and part of the western boundary of close number 151. westwards and southwards along the northern and part of the western boundary of close number 121b, southwestwards along the southern boundary of close number 149b, and in a straight line in continuation thereof to the middle of Saint Paul's
