- REGULATIONS FOR THE RECRUITMENT OF MEN WHO HAVE COMPLETED A PERIOD OF COMPULSORY SERVICE IN H.M. FORCES TO THE CLERICAL CLASSES (GENERAL AND DEPARTMENTAL) OF THE HOME CIVIL SERVICE.
- 1. Nationality.
- Candidates must be British subjects. The also satisfy one of the following conditions:-They must
 - (a) If natural-born British subjects, they must either

(i) have at least one parent who is or was at death a British subject; or
(ii) have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment. appointment.

appointment. (b) If naturalised British subjects, they must have resided in Her Majesty's dominions and/or been employed elsewhere in the service of the Crown for at least five years out of the last eight years preceding the date of their appointment. (c) If not qualified under (a) or (b) of this para-graph they must satisfy the Commissioners that they are so closely connected with Her Majesty's dominions either by ancestry, upbringing or residence, or by reason of national service, that an exception may properly be made in their favour.

2. Education.

No precise educational qualifications are pre-scribed, but candidates will be expected to have attained the standard of education of persons who have had whole-time systematic education up to the age of at least 16 years.

3. Service.

(i) Candidates must have completed before the first (i) Candidates must have completed before the first day of the examination a period of compulsory service in Her Majesty's Forces under the National Service Acts and normally must not have undertaken further whole-time service in Her Majesty's Forces; provided that the Commissioners may at their dis-cretion accept a candidate as eligible under this Regulation if, having completed a period of com-pulsory service in Her Majesty's Forces under the National Service Acts, he has voluntarily undertaken
