The QUEEN has been graciously pleased on the advice of Her Majesty's Australian Ministers, to approve the award of the British Empire Medal (Military Division) in recognition of brave conduct to:—

3/748900 Private (temporary Corporal) Kenneth Norman GRIBBLE, Royal Australian Infantry Corps.

Temporary Corporal K. N. GRIBBLE was on duty at Scrub Hill on the night 8-9th May, 1956, at 4.15 a.m., during a Camp training exercise. When a Private appeared to be unable to throw a lighted stick of gelignite from his hand, GRIBBLE, with complete disregard for his personal safety, rushed to the man's aid. The gelignite charge, however, exploded inflicting serious wounds on both soldiers. Corporal GRIBBLE ensured that the soldier first received prompt medical attention, before he made it known that, he, himself, required medical aid. By his calm level-headed conduct, singular courage and inspiring behaviour he undoubtedly contributed to the preservation of the man's life.
