WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 16th day of November, 1956, in the words and figures following, that is to say:— "We, the Church Commissioners, in pursuance of the Church Patronage Act, 1870, and of the Acts therein mentioned, have prepared the following Scheme for effecting a transfer of the ownership of the interest hereinafter mentioned in the advowson or perpetual right of patronage of and presentation to the church and cure (hereinafter called 'the said benefice') of Great Parndon in the County of Essex and in the diocese of Chelmsford.

## " SCHEME.

"Whereas we are satisfied that the patronage of the said benefice is exercised in a series of three successive turns of presentation of which the Board of Governors of Saint Thomas' Hospital (hereinafter called 'the said Board') as successors to The Mayor and Commonalty and Citizens of the City of London, Governors of the Possessions Revenues and Goods and Commonalty and Citizens of the City of London, Governors of the Possessions, Revenues and Goods of the Hospitals of Edward late King of England the Sixth of Christ Bridewell and Saint Thomas the Apostle, as Governors of Saint Thomas' Hospital are entitled to one turn. ## " SCHEME.

"1. Union of Benefices. The benefice of Simpson and the benefice of Woughton-on-the-Green shall be with cure of souls under the style of 'The United Benefice of Simpson with Woughton-on-the-Green', but the parishes of the said benefices shall continue in all respects distinct.

in all respects distinct. "2. Taking effect of Union. If upon the day when any Order of Your Majesty in Council affirm-ing this Scheme is published in the London Gazette, the benefice of Simpson shall be vacant the union shall forthwith take effect, but if it shall then be full the union shall take effect immediately upon the next vacation thereof, and in either case the Reverend Harold Francome Painter, if he is then incumbent of the benefice of Woughton-on-the-Green, shall with his consent (testified by his signa-ture hereto), be the first incumbent of the united benefice. benefice.

"3. Parsonage House. Without prejudice to the "3. Parsonage House. Without prejudice to the exercise before the date when the union takes effect of any of the powers conferred by the Parsonages Measures, 1938 and 1947, the parsonage houses at present belonging to the benefices of Simpson and Woughton-on-the-Green, if at that date they so belong, and the site and appurtenances thereof and the grounds heretofore usually occupied and enjoyed therewith abali as soon as conveniently may be be the grounds heretofore usually occupied and enjoyed therewith shall, as soon as conveniently may be, be sold and disposed of by us at such time or times and in such manner in all respects as to us shall seem expedient and so much of the net proceeds of such sales as we, after consultation with the Bishop of the diocese, shall approve shall be applied bishop of the clocese, shah approve shah be approve towards the cost of providing a new parsonage house for the united benefice and the balance of such net proceeds shall be held by us on behalf of the united benefice as endowment capital subject to the provi-sions of the Benefices (Stabilisation of Incomes) Measure, 1951.

"4. Patronage. After the union has taken effect the right of presentation to the united benefice shall be exercised by the patrons of the two benefices alternately, the patron of the benefice of Simpson having the first turn of presentation to the united benefice to be made after the union."
