The QUEEN has been graciously pleased to approve the award of the British Empire Medal (Military Division), in recognition of distinguished service in Cyprus, to:—

3449480 Warrant Officer Class II (Acting) Leslie DUNN, The Gordon Highlanders.

On the 17th June, 1956, during operations in the Paphos Forest area of Cyprus a disastrous forest fire trapped a considerable number of troops many of whom lost their lives or suffered severe injury in consequence of the flames. When the magnitude of the emergency was first realised Company Sergeant Major DUNN went at once to investigate and, after sending urgent messages for assistance worked unceasingly throughout the day displaying outstanding initiative, good sense and leadership. Undeterred by the smoke and confusion caused by the fire he entered and re-entered the burning area organising the collection of dead and injured and searches for further possible victims. Showing a complete disregard for exploding ammunition he assisted in pushing burning lorries off the mountain track to clear the way for rescue vehicles. He gave valuable assistance in the organisation and loading of a convoy for the evacuation of the victims. His exceptional devotion to duty, courage and resource were an inspiration to those about him.

DRESSMAKING AND WOMEN'S LIGHT CLOTHING
WAGES COUNCIL (ENGLAND AND WALES).

PETROLEUM (PRODUCTION) ACT, 1934.

MINERAL WORKINGS ACT, 1951.

The Minister of Transport and Civil Aviation hereby gives notice that he has made an Order under s. 49 of the Town and Country Planning Act, 1947, and s. 32 of the Mineral Workings Act, 1951, entitled "The Stopping up of Highways (Derbyshire) (No. 17) Order, 1956" authorising the temporary stopping up for seven years of a length of footpath at Swarkestone Bridge, Stanton-by-Bridge, Derbyshire, and requiring the provision of a temporary new footpath, and requiring the restoration of the old footpath at the end of that period.

Any person aggrieved by the Order and desiring to question the validity thereof, or of any provision contained therein, on the ground that it is not within the powers of the Town and Country Planning Act, 1947, and the Mineral Workings Act, 1951, or that any requirement of these Acts or of any regulation made thereunder has not been complied with in relation to the Order, may, within 6 weeks of the 4th December, 1956, apply to the High Court for the suspension or quashing of the Order or of any provision contained therein.
