**RIVER BOARDS ACT, 1948.**

**Severn River Board Area.**

In pursuance of sub-section (3) of Section 6 of the River Boards Act, 1948, the Minister of Agriculture, Fisheries and Food hereby gives notice that the Severn River Board have made application under the said sub-section that the map approved under sub-section (2) of the said Section showing the extent of the main river for the purposes of Part II of the Land Drainage Act, 1930, be varied by the deletion from the said main river of a short section at Stroud and by the addition to the said main river of parts of the Thames and Severn Canal and the Stroudwater Canal from a point near Wallbridge, Stroud, to a point in Dudbridge, together with the connecting channel to the River Frome.

Plans on which the proposed deletion and additions are shown by lines in yellow and red colour respectively, have been deposited at the Severn River Board's District Office, 20, Clarence Street, Gloucester, and at the offices of the Ministry of Agriculture, Fisheries and Food, Someries House, St. Andrew's Place, Regent's Park, London, N.W.1, for public inspection for a period of thirty-five days from the date of this Notice and may be inspected during normal office hours. **River Thames Above Teddington Lock Catchment
