Discontinuance

THE BURIAL GROUNDS (SANDRIDGE) ORDER, 1956 Made ---- 19th December, 1956

At the Court at Buckingham Palace, the 19th day of December, '1956.

PRESENT,

The QUEEN's Most Excellent Majesty in Council WHEREAS the Minister of Housing and Local Government, after giving 10 days' previous notice of his intention in that behalf, did, under the pro-visions of the Burial Act, 1853 (16 & 17 Vict. c. 134), visions of the Burial Act, 1853 (16 & 17 Vict. c. 134), as amended by subsequent enaciments, make a Repre-sentation to Her Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Sandridge, in the County of Hertford, save with the previous approval of the Minister of Housing and Local Government, should be prohibited, and that burials should be discontinued therein as hereinafter directed.

And Whereas by an Order in Council of the 9th October, 1956, Notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 27th day of November next, and such Order has been published in the Londom Gazette, and copies thereof have been affixed, as required by the said Act:

Now, therefore, Her Majesty is pleased, by and with the advice of Her Privy Council, to order, and it is hereby ordered, as follows:

1. No new burial ground shall be opened in the said Civil Parish of Sandridge save with the previous approval of the Minister of Housing and Local Government, and burials shall be discontinued therein as follows, viz.:

Sandridge.—Forthwith and entirely in the Church-yard of the Parish Church of St. Leonard in the said Parish:

Provided that-

(a) In any vault or walked grave now existing in the said Churchyard, burial may be allowed subject to the condition that every coffin buried in such vault or grave be separately enclosed by stonework or brickwork properly cemented.

(b) In any earthen grave now existing in the said Churchyard, the burial may be allowed of the body of any member of the family of the person or persons heretobefore buried in such grave, subject to the condition that no part of the coffin containing the body shall be at a depth less than three feet below the level of the surface of the ground adjoining the grave.

2. This Order may be cited as the Burial Grounds (Sandridge) Order, 1956.
