BURIAL, ENGLAND. Discontinuance.

The Burial Grounds (Shipton-under-Wychwood) Order, 1957.

Made 24th January, 1957.

WHEREAS the Minister of Housing and Local Government, after giving 10 days' previous notice of his intention in that behalf, did, under the provisions of the Burial Act, 1853 (16 & 17 Vict. c. 134), as amended by subsequent enactments, make a Representation to Her Majesty in Council that for the protection of the Public Health, the opening of any new burial ground in the Civil Parish of Shipton-under-Wychwood, in the County of Oxford, save with the previous approval of the Minister of Housing and Local Government, should be prohibited, and that burials should be discontinued therein as hereinafter directed:

And whereas by an Order in Council of the 29th November, 1956, notice of such Representation was given, and it was ordered that the same should be taken into consideration by a Committee of the Privy Council on the 16th day of January next, and such Order has been published in the London Gazette, and copies thereof have been affixed, as required by the said Act.

Now, therefore, Her Majesty, is pleased, by and with the advice of Her Privy Council, to order, and

1. No new burial ground shall be opened in the said Civil Parish of Shipton-under-Wychwood, save with the previous approval of the Minister of Housing and Local Government, and burials shall be discontinued therein as follows, viz.:

Shipton-under-Wychwood—Forthwith and entirely in the Old Churchyard of the Church of St. Mary

in the Old Churchyard of the Church of St. Mary in the said Parish.

2. This Order may be cited as the Burial Grounds (Shipton-under-Wychwood) Order, 1957.

WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 3rd day of January, 1957, in the words and figures following, that is to say:—
"We, the Church Commissioners, acting in pur-

suance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parish of Monk Bretton in the diocese of Wakefield.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting

it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas we have not approved any consecrated church within the area as suitable to be the parish church of the new parish:

"Now, therefore, with the consent of the Right Reverend Roger, Bishop of Wakefield (in testimony whereof he has set his hand and affixed his episcopal whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:—

1. Constitution:

"(a) As from the date of the licence thereto of a minister, the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be

"(b) As from the date of the consecration of a church within the area approved by us, the said Church Commissioners, as suitable to be a parish church or if the church is consecrated before such approval, the date of the approval, the said area

shall become a new parish.

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of Saint Mary Magdalene, Lundwood'.

"2. Archdeaconry and Rural Deanery:
"The district and parish shall be in the Archdeaconry of Pontefract and in the rural deanery of Archdeaconry and Rural Deanery: Barnsley.

"THE SCHEDULE.

"The area comprising:

"All that part (coloured pink on the map hereto) of the parish of Monk Bretton which lies to the east and southeast of an imaginary line commencing at a point on the boundary which divides the parish of Ardsley from the parish of Monk Bretton in the middle of the Cudworth and Barnsley Branch Railways Line of the British Railways (North Eastern Region) and proceeding thence northeastward along the middle of the said railway line to the centre of the bridge which carries Cliffe Lane across the said railway line and continuing thence eastwards along the middle of Cliffe Lane to the centre of the bridge which carries Cliffe Lane across the Barnsley Branch Canal of the Aire and Calder Navigation and continuing thence generally northeastwards along the middle of the said canal to a point opposite the southwestern end of the footpath which leads from the towing path across close numbered 242 to the Hull (Alexandra Dock) to Stairfoot Branch railway
