RIVER BOARDS ACT, 1948.

Bristol Avon River Board.

In pursuance of subsection (3) of section 6 of the River Boards Act, 1948, the Minister of Agriculture, Fisheries and Food hereby gives notice that the Bristol Avon River Board have made application under the said subsection that the map approved under subsection (2) of the said section showing the extent of the main river for the purposes of Part III of the Land Drainage Act, 1930, be varied by the addition to the said main river of:—

(1) Part of Ladden Brook from a point $\frac{1}{2}$ mile north of Yate Court in the Parish of Wickwar to its confluence with the River Frome in the Parish of Frampton Cotterell, together with a bifurcation and a tributary, both in the Parish of Wickwar.

(2) Part of Kilmersdon Brook, from a point near Fox Hills, Norton Radstock, to its confluence with Wellow Brook, Radstock.

(3) Part of Snail's Brook, from a point $\frac{1}{2}$ mile south west of Radstock to its confluence with Kilmersdon Brook in Norton Radstock.

RIVER BOARDS ACT, 1948.

South West Wales River Board Area.

In pursuance of subsection (3) of Section 6 of the River Boards Act, 1948, the Minister of Agriculture, Fisheries and Food hereby gives notice that the South West Wales River Board have made application under the said subsection that the map approved under subsection (2) of the said Section showing the extent of the main river for the purposes of Part II of the Land Drainage Act, 1930, be varied by the

addition to the said main river of the following watercourses:—

(1) Part of the Afon Dulas from Pont Llangybi in the Parish of Llangybi to its confluence with Afon Teifi at Pont Stephen, Lampeter, including a mill race to the north and a bifurcation to the east of Lampeter.

(2) Part of Afon Dafen from Porth-Dafen, approximately $1\frac{1}{4}$ miles north of Dafen, to its confluence with Burry River at Llanelly.

(3) Part of Afon Morlais from Pont Morlais approximately $\frac{1}{2}$ mile south of Llannon to its confluence with the River Loughor near Llangennech together with two mill races north of Llangennech.

(4) Part of Afon Gwili from Pont Rhyd-y-biswail at Cwmgwili to its confluence with the River Loughor near Hendy, including a mill stream west of Fforest.

(5) Part of Nant-y-fendrod from a point near Ynys-allan Farm, Swansea, to its confluence with the River Tawe, together with part of the Nant-bran from a point near Felin-fran to its confluence with Nant-y-fendrod.

(6) Certain unnamed channels on Llangennith Moors, Gower, Glamorgan.

(7) Village Drain from a point approximately $\frac{1}{2}$ mile south of Pembrey to its confluence with Swan Pool Drain, together with an unnamed watercourse from a point near Pembrey to its confluence with Village Drain.

Plans on which the proposed additions are shown by lines in red colour have been deposited at the office of the Clerk to the South West Wales River Board, Penyfai House, Penyfai Lane in Llanelly, Carmarthenshire, and at the offices of the Ministry of Agriculture, Fisheries and Food, Someries House, St. Andrew's Place, Regent's Park, London, N.W.1, and will be available for public inspection during normal office hours for a period of thirty-five days from the date of this notice. A copy of the statutory map of the River Board Area on which is shown existing main river may also be seen at the above addresses.

Plans on which is shown only the proposed variation numbered (1) above will also be available for public inspection during normal office hours for a similar period at the offices of the Town Clerk, Town Hall, Lampeter, Cardiganshire.
