

Mules (Great Britain) Order of 1938. The principal changes are—

(1) Racehorses, polo ponies, performing horses, horses entered for shows or intended to be exported from Great Britain within 14 days of landing, will not be required to have undergone the mallein test, but must be accompanied by a certificate of an officer of the Government of the exporting country, certifying that the country was for the preceding six months free from glanders, as well as by a declaration by the owner or person in charge of the horse giving certain specified particulars about the horse.

(2) The period during which an imported horse may be required to be tested with mallein is extended to 28 days.

(3) Any horse brought to Great Britain without the prescribed documents may be required to be detained and isolated and subjected to examinations and tests.

Statutory Instruments 1957 No. 487.

Prohibition of Landing of Animals, Carcasses and Animal Products, and Hay and Straw from the Channel Islands Order, 1957. (Made 25th March, 1957.)

This Order, which came into operation on 26th March, 1957, prohibits the landing in Great Britain of animals, carcasses and animal products and hay and straw brought from the Channel Islands (other than Jersey).
