RIVER BOARDS ACT, 1948.

Land Drainage Byelaws.

NOTICE is hereby given that the Nene River Board intend to apply at the expiration of one calendar month from the date of the publication of this notice for the confirmation by the Minister of Agriculture, Fisheries and Food of Byelaws made by the Board for securing the more efficient discharge of their land drainage functions.

The proposed byelaws relate to:—

the mooring of house boats; vessels injuring banks, causing obstruction, or interfering with works; beaching of vessels; injurious navigation; berths and mooring places; vessels sunken or adrift; trees drifting into river; constructions, excavations and pipes in proximity to river; deposit of materials etc. endangering stability of banks; disputes as to works, directions or consents; and certain consequential matters.

During a period of one calendar month from the date of publication of this notice, a printed copy of the said Byelaws will be deposited at the Offices of the Board (as under), and will be open to public inspection, without charge, on any weekday during the usual office hours. During the same period printed copies of the Byelaws will be supplied on demand free of charge to any person appearing to the Board to be interested.

Any objection to the confirmation of the Byelaws should be made in writing and addressed to:—
