RURAL DISTRICT COUNCIL OF PETERSFIELD.

(Footpath No. 6 at Queen Elizabeth Forest, Buriton, and Footpath No. 4 at North Lane, Clanfield),
Revision Order, 1957.

NOTICE is hereby given that the above Order was made on the 25th day of April, 1957, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the parishes of Buriton and Clanfield.

The effect of the Order will be to divert the public right of way on foot commencing at point "A" in Queen Elizabeth Forest, Buriton, and proceeding in a south-easterly direction for a distance of approximately 1,900 feet to the boundary dividing the parishes of Buriton and Clanfield, and then in a southerly direction for a distance of approximately 700 feet to the northern end of North Lane, Clanfield, to a line from the above-mentioned point "A" and proceeding in a curved line in a south-easterly direction for a distance of approximately 1,600 feet to footpath No. 7 in the parish of Buriton, and then along footpath No. 7 in a southerly direction for a distance of approximately 1,200 feet to the boundary dividing the parishes of Buriton and Clanfield, and then proceeding in a south-westerly direction along footpath No. 5 in the parish of Clanfield, for a distance of approximately 650 feet to the northern end of North Lane, Clanfield.

Rural District Council of Deben (County Borough of Ipswich, and Parishes of Tuddenham and Rushmere St. Andrew No. 1) Extinguishment Order, 1957.

NOTICE is hereby given that the above Order was made on the 25th day of April, 1957, and is about to be submitted to the Minister of Housing and Local Government for confirmation.

The Order relates to land situate in the county borough of Ipswich, and the parishes of Tuddenham and Rushmere Saint Andrew, in the Rural District of Deben, in the county of Suffolk.

The effect of the Order will be to extinguish the public right of way commencing at a point 250 yards West of Allens Farm on a lane connecting that farm with the Tuddenham Road, Ipswich, and running in a South South Easterly direction for a distance of approximately 150 yards across the ordnance survey enclosure numbered 85 in the county borough of Ipswich, and thence in a South Easterly direction into the Parish of Tuddenham, in the Rural District of Deben, for a distance of approximately 160 yards approximately along the Southern or South Western side of the ordnance survey enclosure numbered 247 in the parish of Tuddenham, just North of the Tuddenham-Westerfield Parish boundary and thence in a South Easterly direction into the Parish of Rushmere Saint Andrew following the Northern or North Eastern boundaries of the ordnance survey enclosures numbered 152 and 147 for a distance of approximately 185 yards then turning due East for a distance of approximately 68 yards across the said ordnance survey enclosure numbered 147 terminating at a point on Tuddenham Lane opposite Rose Cottages and 330 yards South South East of Allens Farm.

DECLARATIONS OF CAERLAVEROCK, ST. KILDA AND
RHUM NATURE RESERVES.

NOTICE is hereby given, in pursuance of section 19 of the above-mentioned Act, that by the Caerlaverock Nature Reserve Declaration, 1957, the St. Kilda Nature Reserve Declaration, 1957, and the Rhum Nature Reserve Declaration, 1957, all made on the 4th day of April, 1957, it was declared by the Nature Conservancy that the lands (First) and (Second) hereinafter described are now the subjects of Agreements entered into with them under the provisions of the Act, and the land (Third) hereinafter described has been acquired and is being held by them, namely:—

(First) (1) Lands comprising three areas of ground extending in all to 1,500 acres or thereby, comprising part of the estate of Caerlaverock, in the Parish of Caerlaverock and County of Dumfries, and

(2) Land consisting of the portion of the foreshore of the Solway Firth known as Blackshaw Bank, lying *ex adverso* part of the said estate of Caerlaverock and between the channels of the River Nith and the Lochar Water, in the Parishes of Caerlaverock and Ruthwell and County of Dumfries;

Which whole lands (First) above mentioned are shown tinted pink and outlined by a red line on the map attached to the relative Declaration;

(Second) Land consisting of the St. Kilda Group of Islands, in the Parish of Harris and County of Inverness, as shown tinted pink on the map attached to the relative Declaration; and

(Third) Land consisting of the Island of Rhum, in the Parish of the Small Isles and County of Inverness, as shown tinted pink and enclosed within a red line on the map attached to the relative Declaration.

And it was further declared that the whole of the above-mentioned lands are being managed as nature reserves.
