The Lords Commissioners of Her Majesty's Treasury hereby give notice that They have made an Order under Section 8 of the Finance Act, 1948, viz.:—

The Safeguarding of Industries (Reduction of Rates) Order, 1957, which amplifies the list of gauges and measuring instruments of precision on which, in pursuance of the May, 1956, Protocol to the General Agreement on Tariffs and Trade, the rate of duty to be charged is to be 25 per cent. ad valorem. The added items (viz. certain balancing machines, block levels, scales and surface finish testing instruments) would, but for this Order, be liable to duty at the rate of 33½ per cent. ad valorem under the Key Industry Duty (List No. 6—Gauges and Measuring Instruments) Order, 1957 (S.I. 1957/1043).

The Order came into operation on the 5th July, 1957, and has been published as Statutory Instruments 1957, No. 1180.

The Safeguarding of Industries (Exemption) (No. 2) (Amendment) Order, 1957, which amends the Tariff description of certain crystals which are temporarily exempted from Key Industry Duty.
