#### MIERICHIANIDIISE MIAIRIKIS ACT, 1926.

Application for the Marking of Certain Imported Articles of Men's, Boys', Women's and Girls' Clothing made from Woven Cloth

In accordance with the provisions of sub-section 4 of section 2 of the Merchandise Marks Act, 11926, the Board of Trade hereby announce that Act, 11926, the Board of Trade nereby authorate manifering pursuance of an application received by them for the making of an Order in Council to require imported goods of certain classes and descriptions to bear an indication of origin, they have made a reference to the Standing Committee appointed by the Board of Trade under the Act in respect of the following imported goods made from woven cloth:

Men's and boys' shirts and pyjamas; Men's, boys', women's and girls' aprons and overalls, including overall jackets, overall longcoats, overall trousers, boiler suits and bib and brace overalls; Men's and boys' long trousers of cotton including jeans and slacks, but excluding trousers imported as part of a suit, and excluding shorts; Women's and girls' cotton trousers including slacks and jeans, but excluding shorts. jeans, but excluding shorts.

Attention is called to the fact that, while under the provisions of the Act the Committee must in every case referred to them consider whether the goods should bear an indication of origin at the time of sale or exposure for sale, they have dis-cretion also to consider and report whether such goods should bear an indication of origin at the time of importation.

Representations of any interests substantially affected by the application who desire to be heard in opposition at the public enquiry, which will be held later by the Committee, should write to the Secretary, Merchandise Marks Committee, Board of Trade, Room 1393, Horse Guards Avenue, Whitehall, London, S.W.1, as soon as possible and not later than September 9, 1957.
