The Minister of Transport and Civil Aviation in accordance with the London Traffic Act, 1924, s. 10, as amended, proposes to refer to the London and Home Counties Traffic Advisory Committee for their advice and report a proposal that he should make regulations to restrict waiting by vehicles between the hours of 8.30 a.m. and 6.30 p.m. on Mondays to Saturdays inclusive in:—

1. Bishops Bridge Road—between its junction with Eastbourne Terrace and its junction with

Westbourne Terrace.
2. Church Street—between its junction with Edgware Road and its junction with Paddington

Green.

3. Paddington Green—from its junction with Church Street westward for a distance of 50 feet.
4. Porchester Road—between its junction with Bishops Bridge Road and its junction with Westbourne Park Road.

(Exemptions will be provided in the regulations to permit vehicles to wait—to pick up and set down passengers, to load and unload goods, to carry out essential services, or while in use by local authorities in an emergency.)
