4. Qualifications.

Candidates must on the closing date for the receipt of applications be barristers called to the English bar of solicitors admitted in England. A period in chambers, experience at the bar or in a solicitor's office, or other legal experience (particularly experience of work similar to that carried out in the legal branches of one or more of the departments in which vacancies are to be filled), will be an advantage.

5. Competition.

7. Assignment.

A candidate who declines to accept the post offered will have no claim to be assigned to another, but will be regarded as having declined appointment. Assignments will be made in accordance with the needs of the public service, but the wishes of candidates will, where possible, be taken into account.

8. Marriage Gratuity.

Persons who have been trained as teachers, elsewhere than in England and Wales, and upon whose training public money has been spent, cannot be appointed until the consent of the appropriate education authority (e.g. the Scottish Education Department, the Ministry of Education for Northern Ireland), has been notified to the Commissioners.

10. Canvassing.

Any attempt on the part of candidates to enlist support for their applications through Members of Parliament or other influential persons, except as referees to be named by them in their application forms, will disqualify them for appointment.

Every successful candidate will be required to pay a fee of £4 before the issue of a certificate of qualification for appointment.
