"We, the Church Commissioners, acting in pursuance of the New Parishes Measure, 1943, have prepared and humbly lay before Your Majesty in Council the following Scheme for constituting a new parish to be taken out of the parishes of Saint Christopher, Bare; Poulton; Saint Laurence, Morecambe; Overton; and Saint Luke, Skerton, in the diocese of Blackburn.

## "SCHEME.

"Whereas we, the Church Commissioners, are satisfied that the spiritual interests of the area defined in the subjoined Schedule and delineated on the map hereto annexed would be best served by constituting it a new parish:

"And whereas we are satisfied that a suitable endowment therefor will be provided:

"And whereas there is no consecrated church within the area and the church of The Ascension therein has been approved by us, the said Church Commissioners, as suitable to be the parish church of the new parish and is intended to be consecrated:

"Now, therefore, with the consent of the Right Reverend Walter, Bishop of Blackburn, (in testimony whereof he has set his hand and affixed his episcopal seal to this Scheme), we, the said Church Commissioners, do humbly recommend and propose as follows, that is to say:

"(a) As from the date of the licence thereto of a Minister the area defined in the subjoined Schedule and delineated on the map hereto annexed shall be

a separate district for spiritual purposes until the consecration of the church of The Ascension therein situated

"(c) The name of the district (or parish as the case may be) shall be 'The District (or Parish) of The Ascension, Torrisholme'
