

**Proposed New Footpath No. 1.**

Approximately parallel with the existing footpath described above commencing and finishing at the aforesaid terminal points but having a length of 650 feet, marked A-D-B and coloured purple as indicated in Map. A new stile will be provided at point "D".

**Existing Footpath No. 2 (Marked C-B and coloured Brown on Map).**

Over O.S.225 and O.S.64 from a point (marked "C" on Map) 300 feet north of an existing stile (marked "S.3" on Map) for a distance of 550 feet in a northerly direction to a point (marked "B" on Map) 70 feet south of the existing stile in O.S.64 (marked "S.2" on Map).
