WHEREAS the Church Commissioners have duly prepared and laid before Her Majesty in Council a Scheme bearing date the 24th day of October, 1957, in the words and figures following, that is to say:—

"We, the Church Commissioners, acting in pursuance of the Pastoral Reorganisation Measure, 1949, and the Union of Benefices Measures, 1923 to 1952, now humbly lay before Your Majesty in Council the following Scheme which we have prepared with the consent of the Right Reverend Michael, Bishop of Saint Albans (in witness whereof he has signed this Scheme), for (1) effecting the union of the benefice of Westoning and the benefice of Tingrith and (2) altering the boundaries of the parishes of Westoning, Tingrith and Harlington, all of which benefices and parishes are situate in the diocese of Saint Albans.

"SCHEME.

"1. Union of Benefices. The benefice of Westoning and the benefice of Tingrith shall be permanently united together and form one benefice with cure of

souls under the style of 'The United Benefice of Westoning with Tingrith' but the parishes of the said benefices shall continue in all respects distinct.

"2. Taking effect of union. Upon the day when any Order of Your Majesty in Council affirming this Scheme is published in the London Gazette the union shall forthwith take effect.

"3. Parsonage House. Upon the union taking effect the parsonage house at present belonging to the benefice of Westoning shall be the house of residence of the incumbent of the united benefice.

"4. Patronage. In every series of three successive turns of presentation to be made to the united benefice after the union has taken effect, the patron of the benefice of Westoning shall have the first and second turns and the patron of the benefice of Tingrith shall have the third turn.

"5. Archdeaconry and Rural Deanery. The united benefice shall be in the Archdeaconry of Bedford and the rural deanery of Ampthill.

"6. Alteration of Parish Boundaries. Upon the
